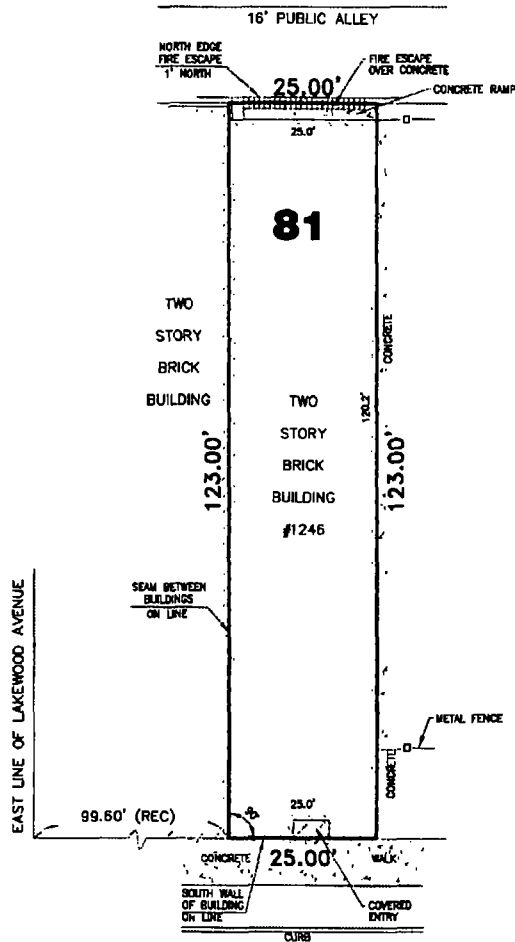
to those of an RT4 Residential Two-Flat, Townhouse and Multi-Unit District.

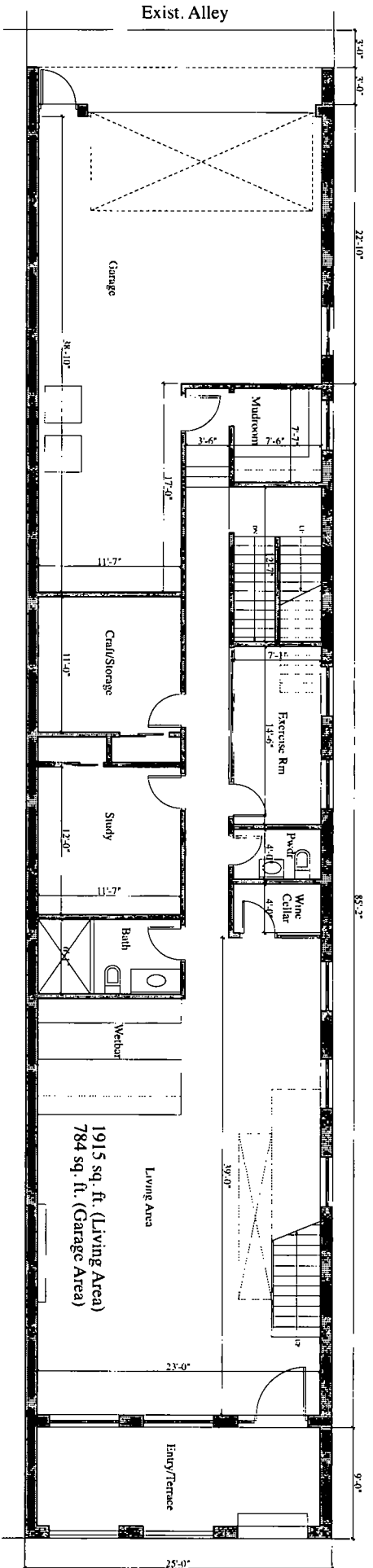

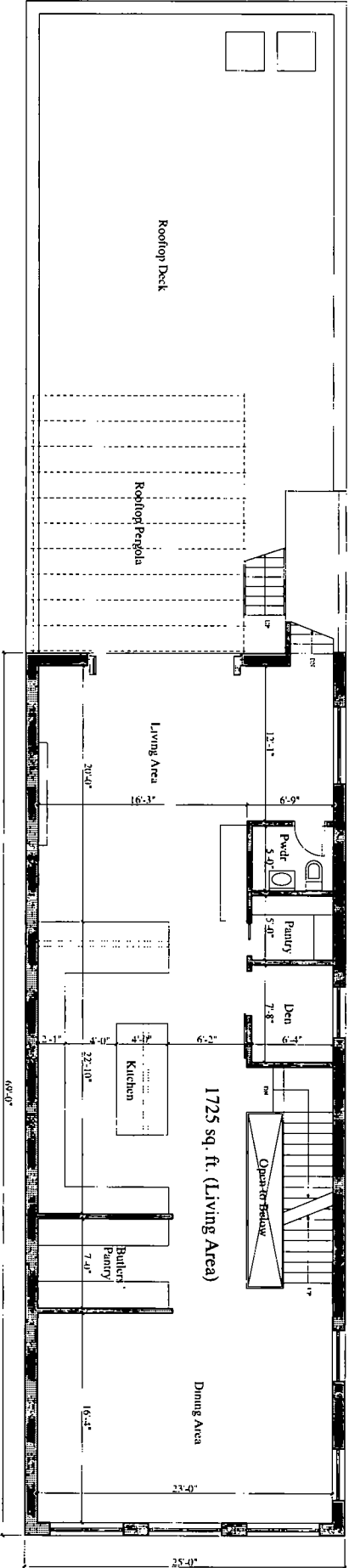
Site Plan

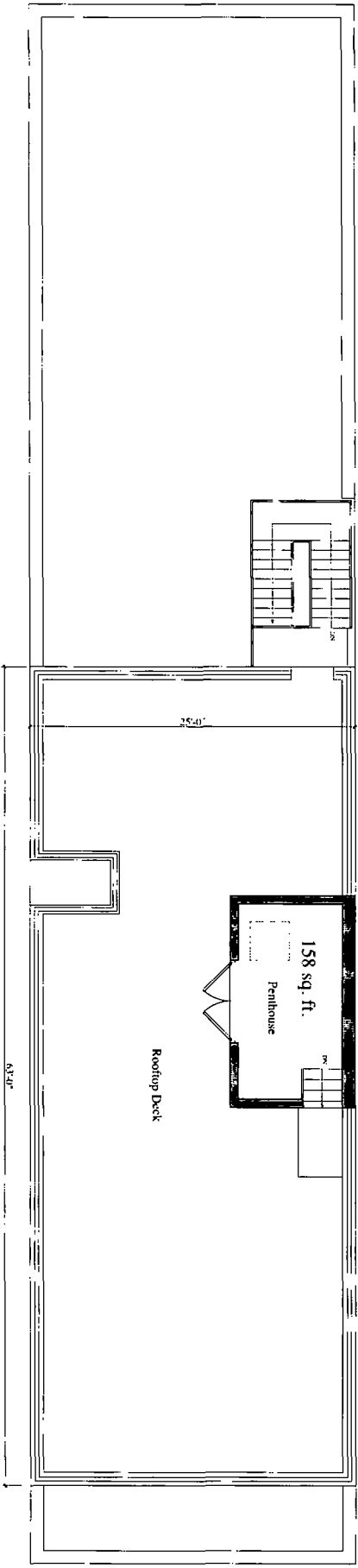
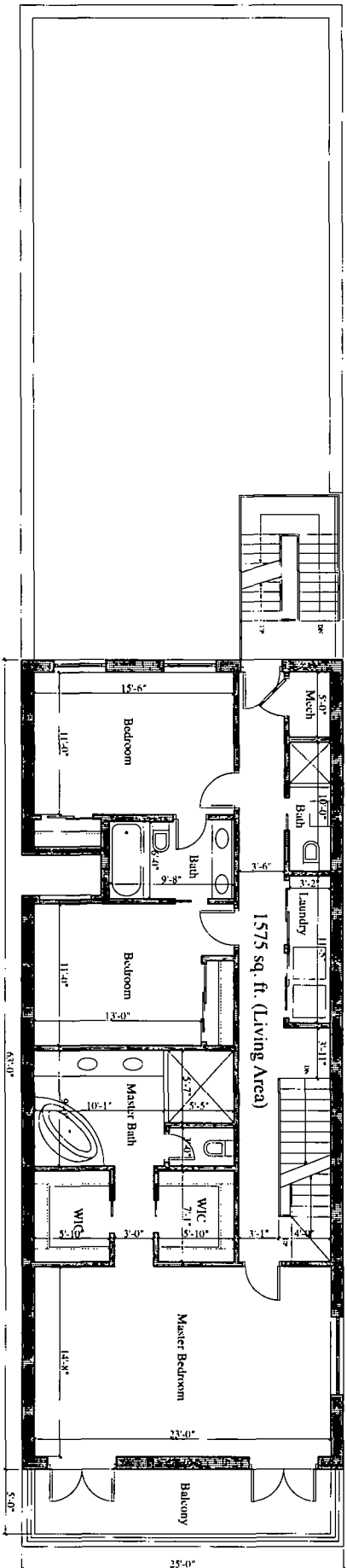
Proposed First Floor Plan

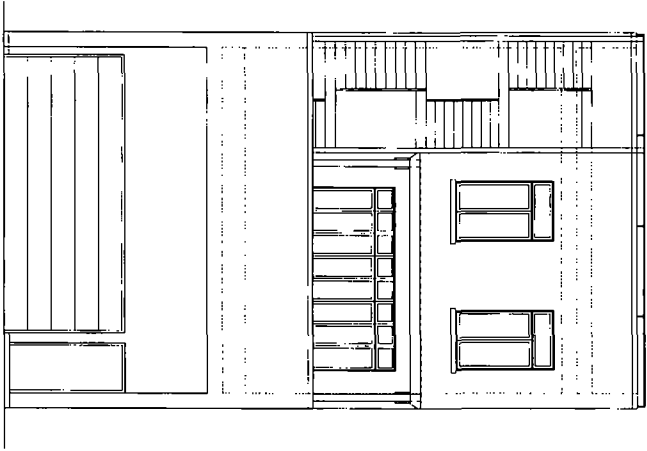

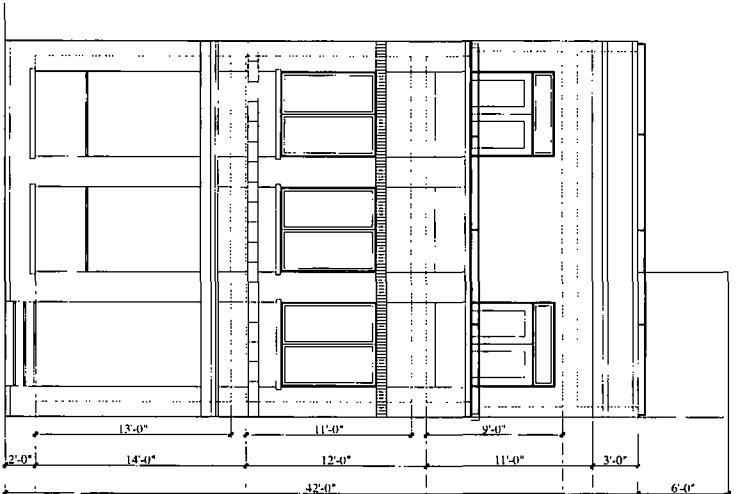
Proposed Second Floor Plan

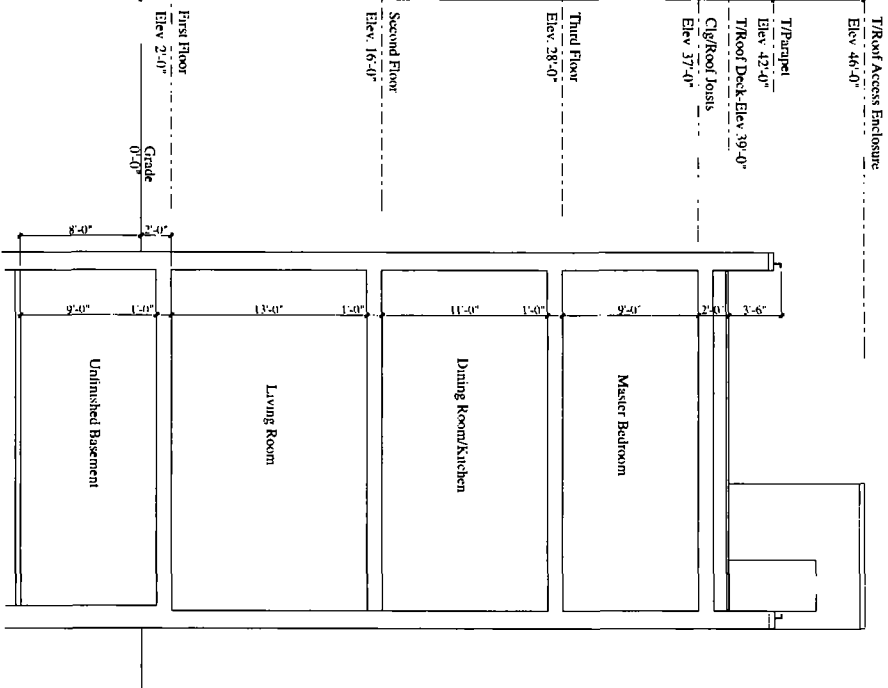




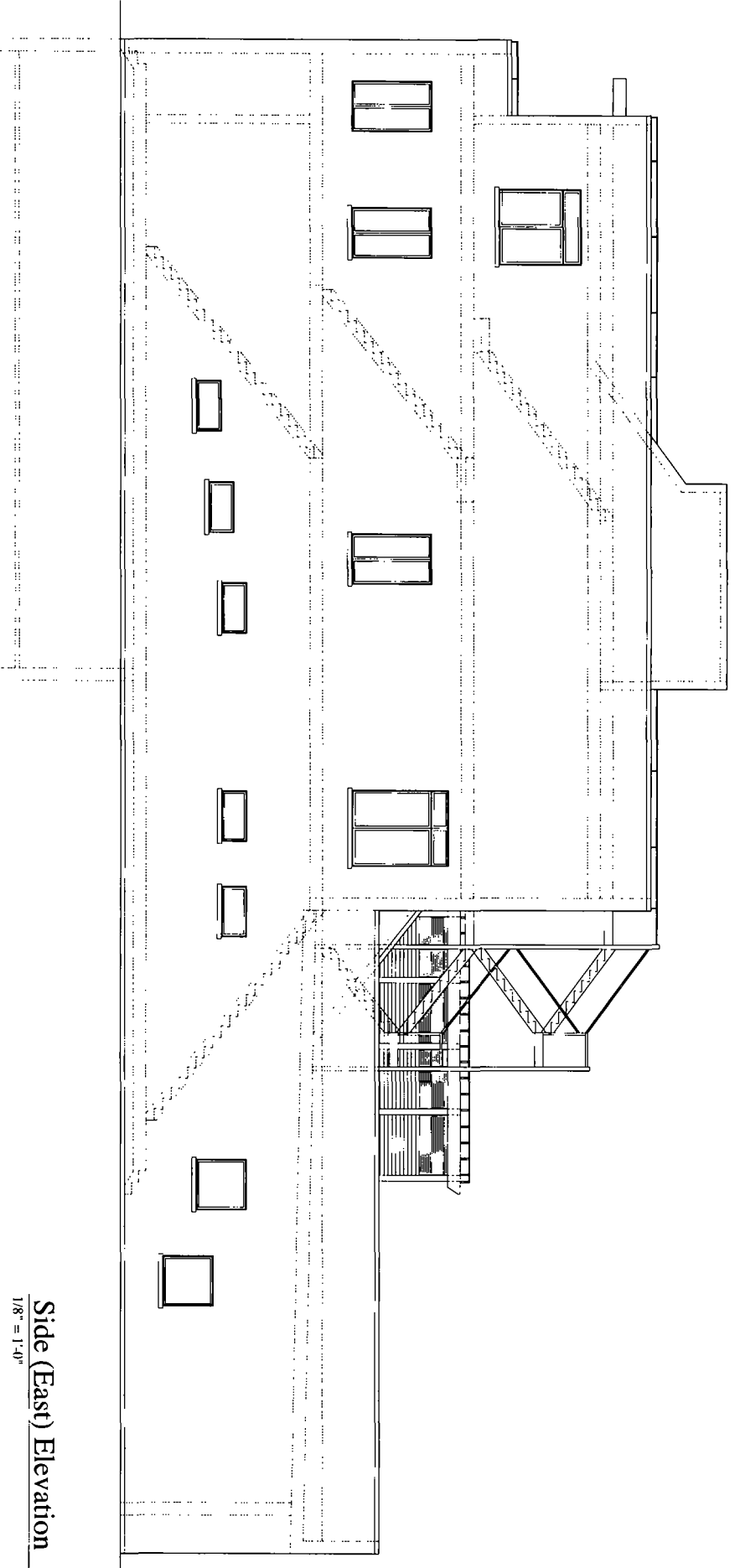
Rear (North) Elevation

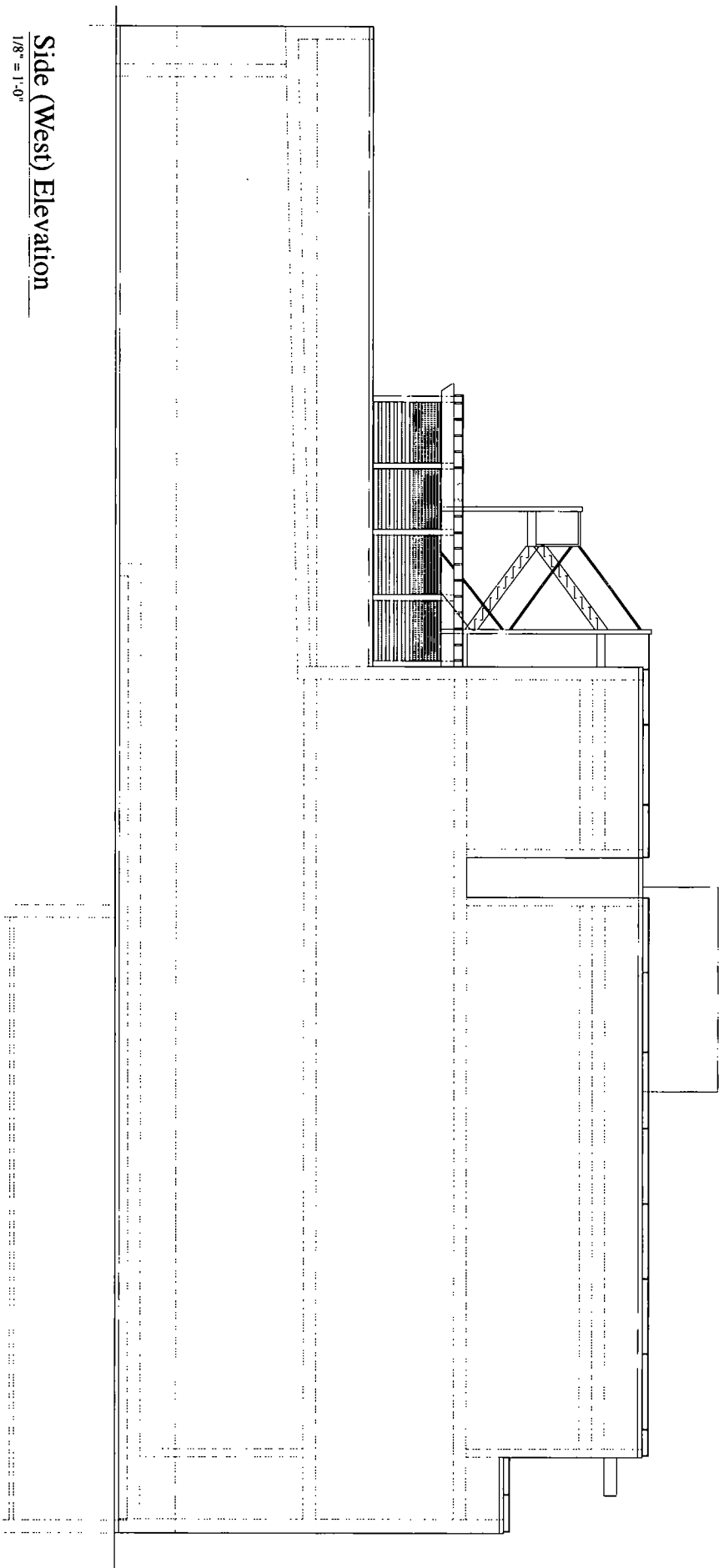


Building Section

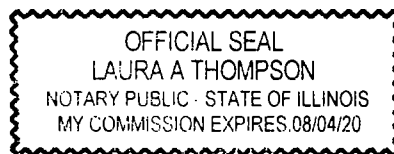

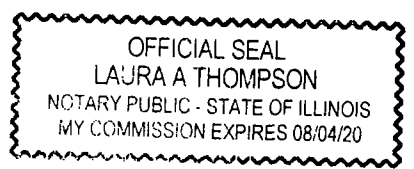
