SUBSTITUTE ORDINANCE

WHEREAS, the Annual Appropriation Ordinance for the year 2012 of the City of Chicago (the "City") contains estimates of revenues receivable as grants from agencies of the state and federal governments and public and private agencies; and

WHEREAS, in accordance with Section 8 of the Annual Appropriation Ordinance, the heads of various departments and agencies of the City have applied to agencies of the state and federal governments and public and private agencies for grants to the City for various purposes; and

WHEREAS, the City, through its Department of Public Health has federal carryover grant funds in the amount of \$1,000 from the United States Department of Health and Human Services, Centers for Disease Control and Prevention which shall be used for the Tuberculosis Control program; and

WHEREAS, the City, through its Department of Family and Support Services ("DFSS") has been awarded additional federal grant funds in the amount of \$84,000 by the Illinois Department of Commerce and Economic Opportunity which shall be used for the ARRA -WIA NEG on the Job Training program; and

WHEREAS, the City, through DFSS has been awarded public grant funds in the amount of \$145,000 from the County of Cook which shall be used for the One Summer Plus Program; and

WHEREAS, the City, through its Department of Housing and Economic Development ("HED") has been awarded private grant funds in the amount of \$25,000 by The Chicago Community Foundation which shall be used for the Small Grants Training Program; and

WHEREAS, the City, through HED has been awarded federal grant funds in the amount of \$766,000 by the United States Department of Housing and Urban Development which shall be used for the Woodlawn Choice Neighborhood Initiative; and

WHEREAS, the City, through its Department of Police ("Police") has been awarded federal grant funds in the amount of \$25,000 by the Board of Education of the City of Chicago which shall be used for the REMS (Readiness for Emergency Management for Schools) Grant Project SECURE program; and

WHEREAS, the City, through Police has federal carryover grant funds in the amount of \$6,000 from Bethel New Life, Inc. which shall be used for the Weed and Seed Community Garfield project; and

WHEREAS, the City, through its Office of Emergency Management and Communications has federal carryover grant funds in the amount of \$20,000 from the United States Department of Homeland Security which shall be used for the 2007 Supplemental Port Security Grant program; and

WHEREAS, the City through its Department of Transportation has been awarded federal grant funds in the amount of \$294,000 by the United States Environmental Protection Agency for the Calumet Hydrologic Master Plan Implementation at Big Marsh Wetland in the City's Calumet Open Space Reserve (the "Big Marsh Project") and now desires to assign the grant award to the Chicago Park District; now, therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. The sum of \$1,072,000,000 not previously appropriated has become available for appropriation for the year 2012, and is hereby appropriated from Fund 925 - Grant Funds for the year 2012 and designated in conformity with Federal accounting requirements, The Annual Appropriation Ordinance is hereby amended by striking the words and figures and adding the words and figures indicated in the attached Exhibit A which is hereby made a part hereof.

SECTION 2. The Commissioner of the Department of Transportation is hereby authorized to enter into an assignment agreement, subject to the approval of the Corporation Counsel, with the Chicago Park District in connection with the grant award for the Big Marsh Project.

SECTION 6. To the extent that any ordinance, resolution, rule, order or provision of the Municipal Code of Chicago, or part thereof, is in conflict with the provisions of this ordinance, the provisions of this ordinance shall control. If any section, paragraph, clause or provision of this ordinance shall be held invalid, the invalidity of such section, paragraph, clause or provision shall not affect any of the other provisions of this ordinance.

SECTION 7. This ordinance shall be in full force and effect upon its passage and approval.
