WHEREAS, The Honorable Rubén Castillo has been sworn in as the first Latino Chief Judge of the United States District Court for the Northern District of Illinois; and

WHEREAS, The Chicago City Council has been informed of this event by Alderman Edward M. Burke; and

WHEREAS, The son of a Mexican immigrant father and Puerto-Rican born mother, the Honorable Rubén Castillo was raised in the West Town neighborhood; and

WHEREAS, The Honorable Rubén Castillo attended Gordon Tech High School and Loyola University Chicago before graduating from Northwestern University Law School; and

WHEREAS, The Honorable Rubén Castillo joined the law firm of Jenner & Block and served under federal prosecutor Dan Webb; and

WHEREAS, The Honorable Rubén Castillo concluded his tenure at the U.S. Attorney's Office in 1988 to serve as the director and legal counsel for the Mexican American Legal Defense and Education Fund in Chicago; and

WHEREAS, The Honorable Rubén Castillo joined the law firm of Kirkland & Ellis LLP as a partner; and

WHEREAS, In 1994, President William Jefferson Clinton named the Honorable Rubén Castillo to the federal bench; and

WHEREAS, For nearly two decades, the Honorable Rubén Castillo has earned the respect and admiration of his peers for his wide-ranging knowledge of the law and commitment to best practices; and

WHEREAS, As Chief Judge, the Honorable Rubén Castillo supervises matters of great sensitivity, including grand jury empanelling, whistleblower suits filed under seal and federal requests to install wiretaps or conduct other forms of electronic surveillance; and
