The alley next north of West Harrison Street; a line 324.83 feet east of South Francisco Avenue; West Harrison Street; and South Francisco Avenue

to those of a RM5 Residential Multi-Unit District.

SECTION 2. This Ordinance shall be in force and effect from and after its passage and due publication.

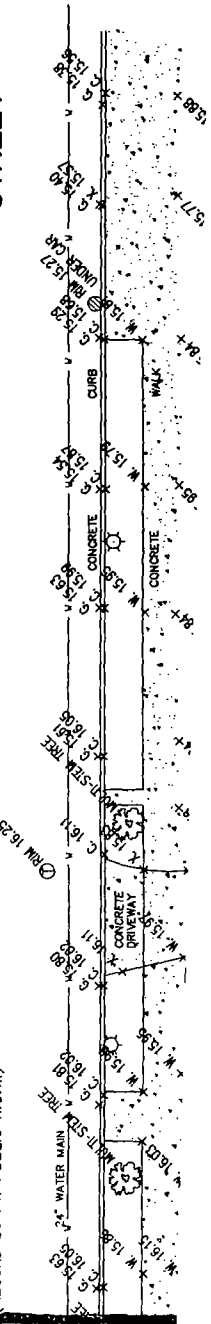
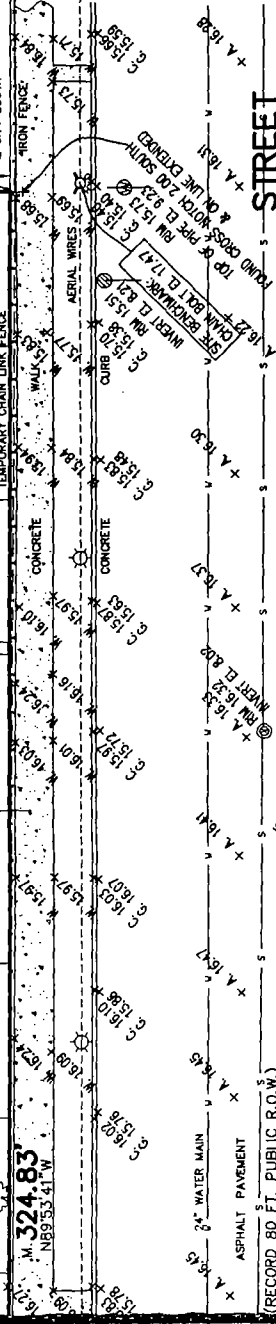
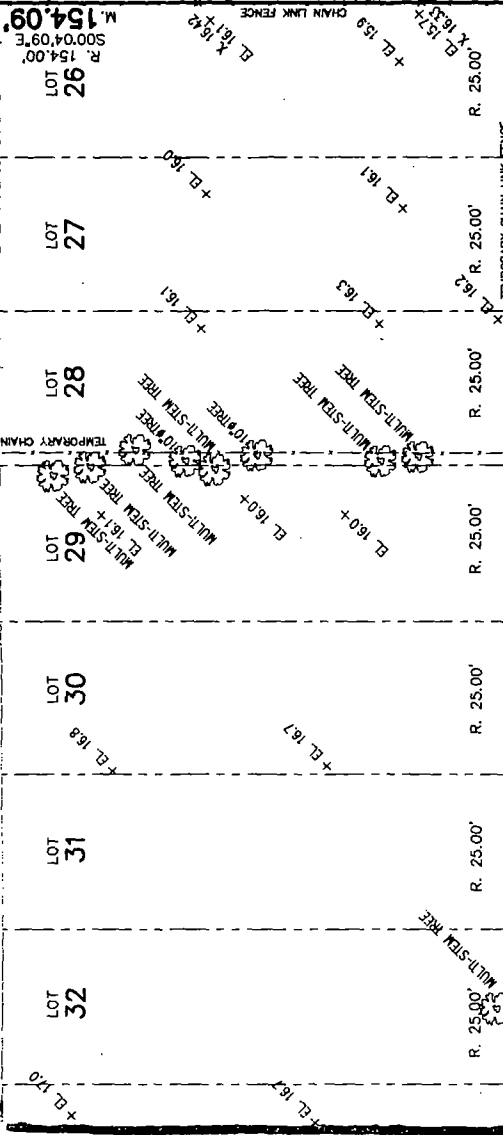
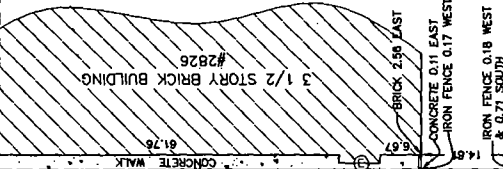
VICINITY MAP
