ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of B1-1 Neighborhood Shopping District symbols and indications as shown on Map No. 117-B in the area bounded by

The public alley northwest and parallel to South Archer Avenue; South Lock Street; South Archer Avenue; A line 36.07 feet southwest and parallel to South Lock Street to those of a B1-3 Neighborhood Shopping District.
