WHEREAS, Marilyn Jackson will be deeply missed by all and especially by those who shared her warmth and compassion. The loving memories of cherished times will help sustain her family and friends through this difficult period of time; and

WHEREAS, Marilyn Jackson leaves to celebrate her life and cherish her memory her devoted husband, Pastor Thomas Jackson, Jr.; sister, Cleola Mae Bates; four children, Toby, Thomas III (Marie); Mark and Judie; twelve grandchildren; thirteen great grandchildren; a special niece Debra Ridgner and a host of other loving nieces, nephews, cousins, friends and neighbors.
