ORDINANCE ARGUS FINANCIAL SERVICES, LTD. Acct. No. 260928 - 1 Permit No. 1114580

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to ARGUS FINANCIAL SERVICES, LTD., upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, three (3) Awning(s) projecting over the public right-of-way adjacent to its premises known as 6841 W. Archer Ave..

Said Awning(s) at W. Archer Avenue measure(s):

Two (2) at seven (7) feet in length, and one point eight (1.8) foot in width for a total of twenty-five point two (25.2) square feet.

One (1) at five (5) feet in length, and two point five (2.5) feet in width for a total of twelve point five (12.5) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1114580 herein granted the sum of one hundred fifty (\$150.00) per annum in advance.

A 25% penalty will be added for payments received after due date.


