BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B3-1, Community Shopping District symbols and indications as shown on Map No. 13-L in the area bounded

A line 66.25 feet northwest of and parallel to West Foster Avenue; the public alley next northeast of and parallel to North Milwaukee Avenue; West Foster Avenue; and North Milwaukee Avenue

to those of a C1-1, Neighborhood Commercial District.

Section 2. This ordinance takes effect after its passage and approval.

Dear Mr. Citron:

The subject site is zoned B3-1, Community Shopping District. The subject site is improved with a 6,884 square foot, one and two-story commercial building. The subject site does not have any on-site parking. The property was previously used for office and retail uses. The parking standard for the last permitted use was based on the floor area of the building resulting in a requirement of seven (7) parking spaces. Pursuant to section 17-10-0101-C of the Chicago Zoning Ordinance the site is given a credit for an existing deficiency of seven (7) parking stalls.

The information provided in your letter dated May 17, 2012, describes the proposed use of the site and the required zone change that will be sought. Based on that information the proposed use, classified as limited manufacturing has a parking requirement of one (1) parking space for each four (4) employees. Your letter indicated that there would be no more than twenty-five (25) employees at this site resulting in a parking requirement of six (6) spaces. The existing parking deficiency is set at seven (7) spaces and therefore no additional parking is required.
