BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS-3 Residential Single-Unit (Detached House) District symbols and indications as shown on Maps No. 1-L, in area bounded by

A line 331.00 feet north of and parallel to West Ohio Street; North Long Avenue;
A line 281.00 feet north of and parallel to West Ohio Street; the public alley next west of and parallel to North Long Avenue

To those of a RT-4 Residential Two-Flat, Townhome and Multi-Unit District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.





The property measuring approximately 50 feet width by 158 feet depth will be subdivided into two lots, with each lot measuring approximately 25 x 158 feet.






