## TYPE 1 ZONING AMENDMENT

### 1918 N Mendell Street

The Applicant seeks to rezone from M3-3 Heavy Industry District to a C3-3 Commercial, Manufacturing and Employment District

The Applicant seeks to adaptively reuse the existing 4-story building and construct a one-story addition over the surface parking lot and add a new sidewalk along the front property line. The Applicant seeks to utilize the first and second floors of the building with a day care use. The third and fourth floors will contain general office uses. The property is a TSL due to its proximity to the Clybourn Metra Station. No parking is required or will be provided. The height of the building will remain existing at 47' 11 1/2 " to the roof.

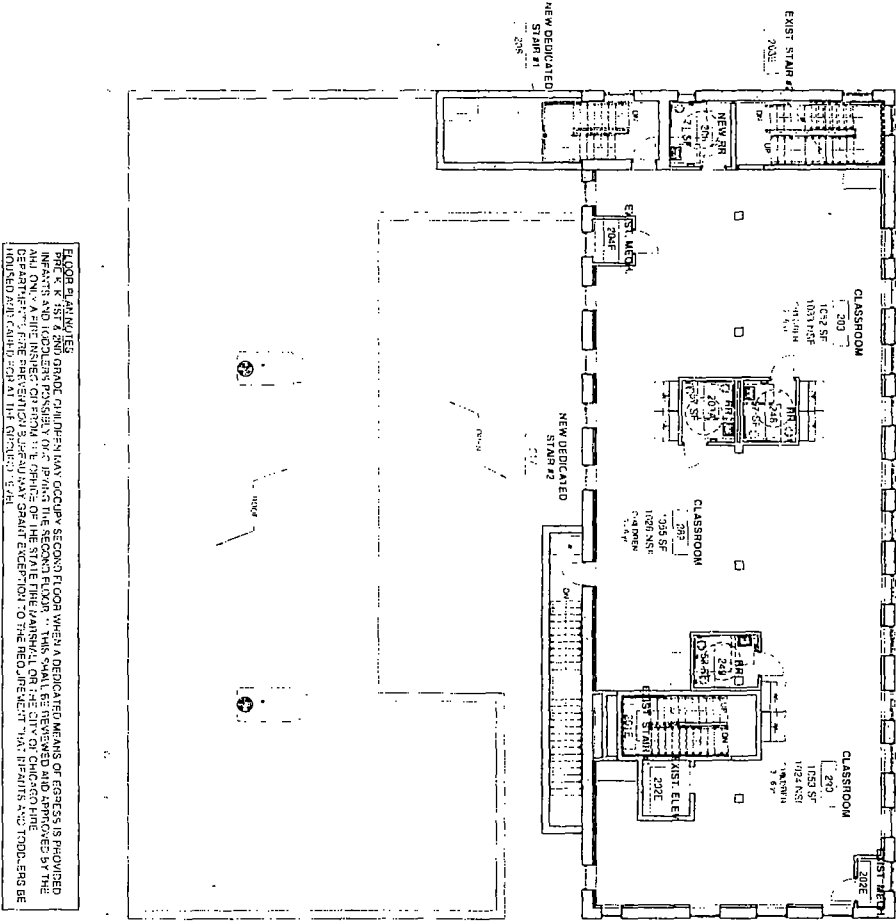

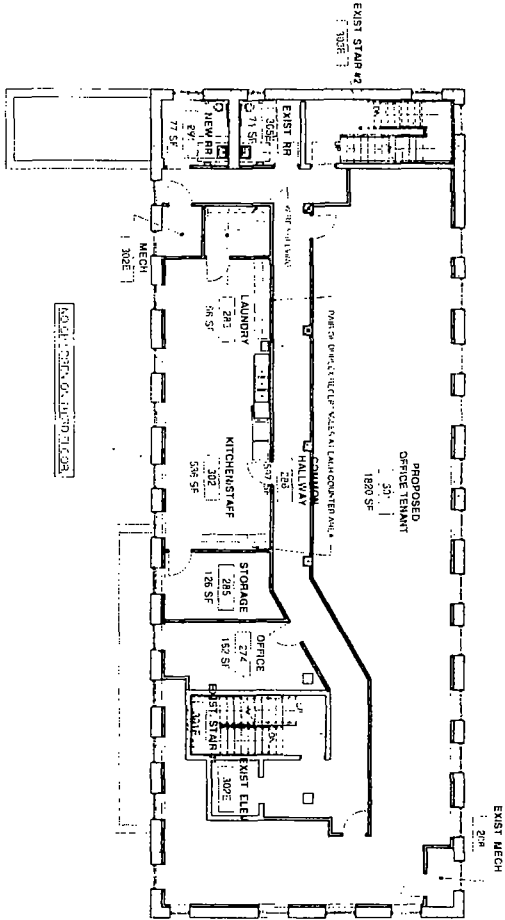

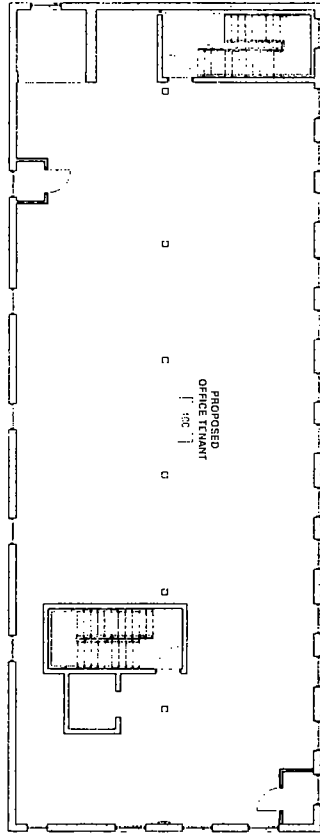
