VICINITY MAP

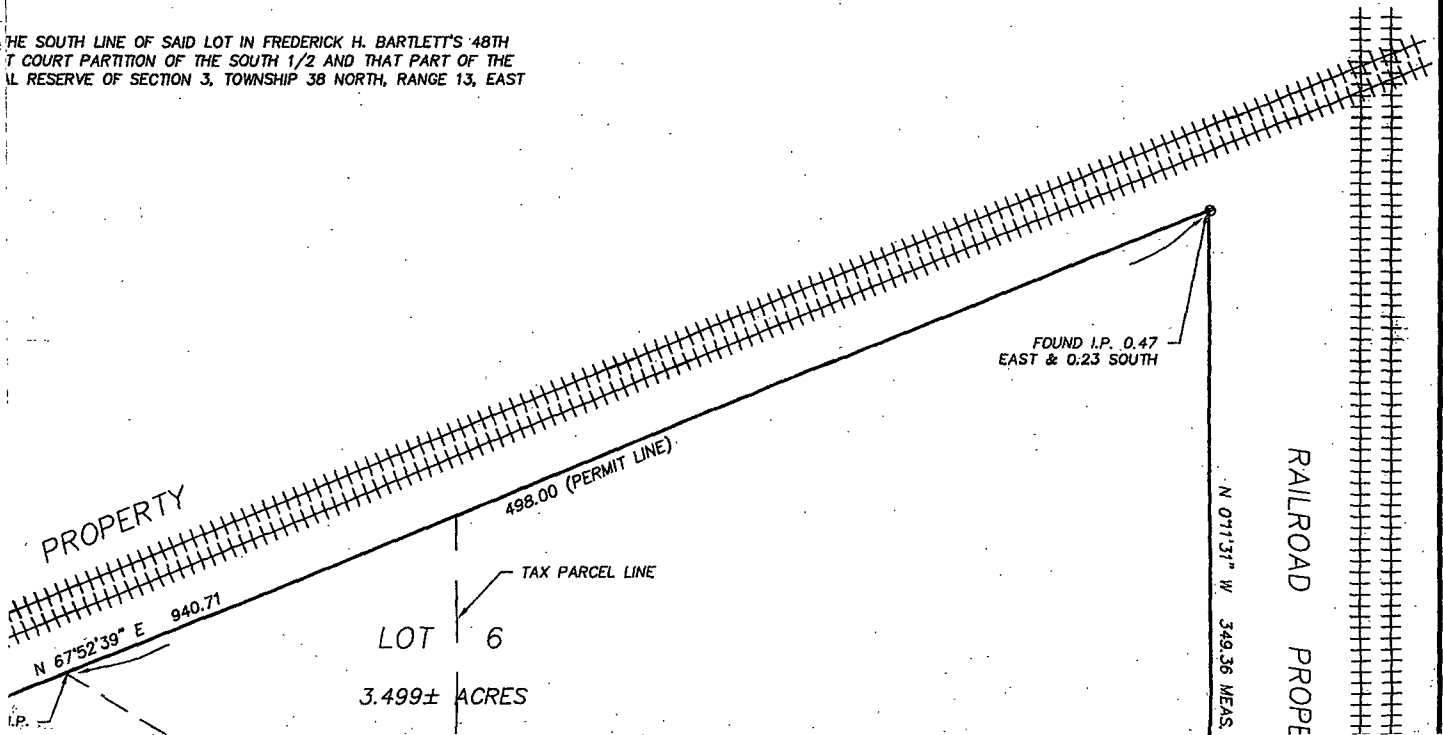

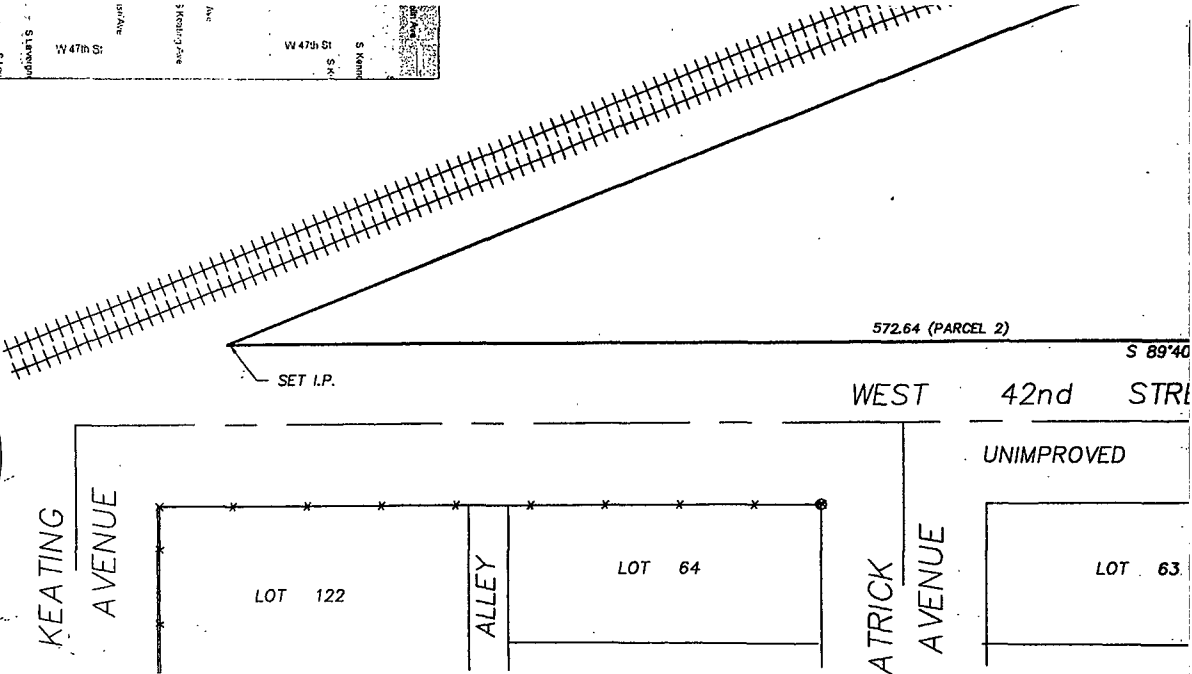

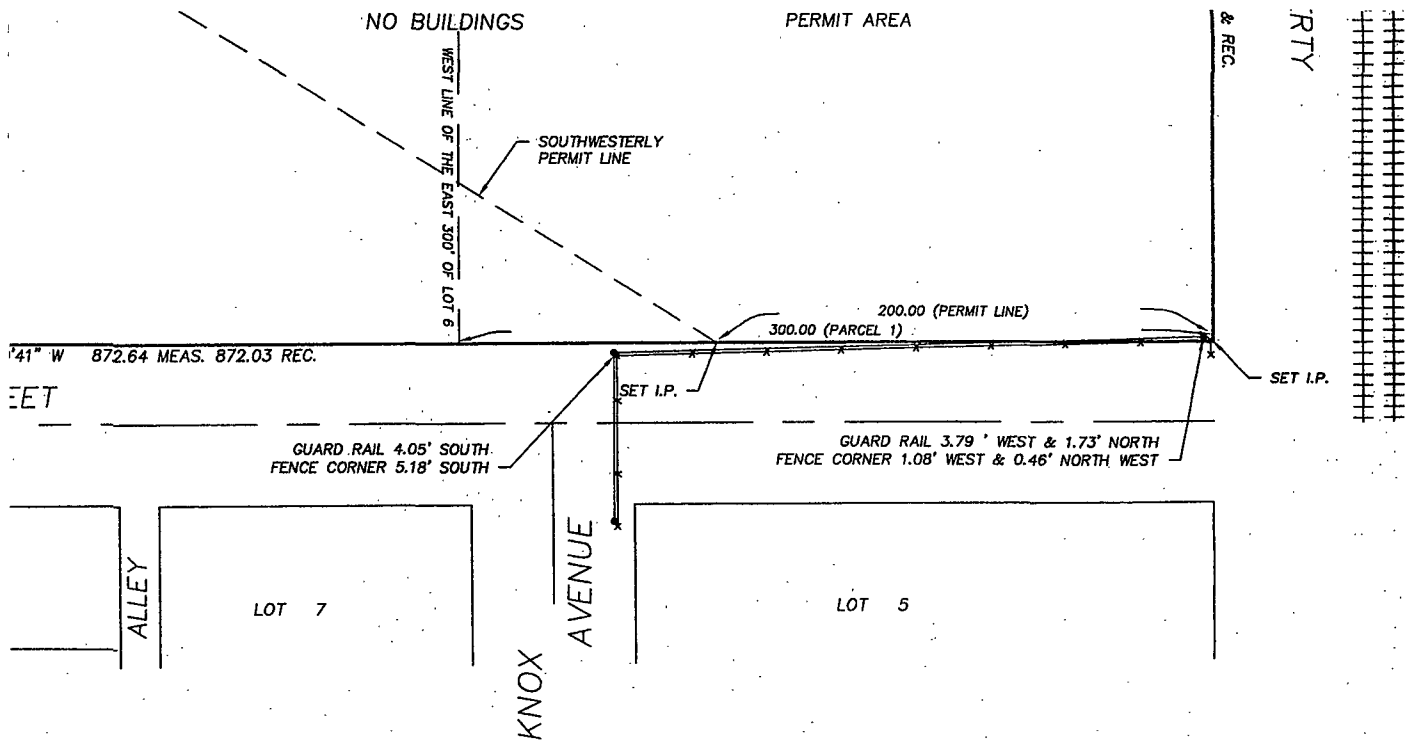
