Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to RAY BUICK INC, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, one (1) Facade(s) on the public right-of-way adjacent to its premises known as 5011 W. 63rd St..

Said Facade(s) at W. 63rd Street measure(s):

One (1) at twenty (20) feet in length, and three (3) feet in width for a total of sixty (60) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development and Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.


The grantee shall pay to the City of Chicago as compensation for the privilege #1099015 herein granted the sum of four hundred (\$400.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

Authority herein given and granted for a period of five (5) years from and after Date of Passage.

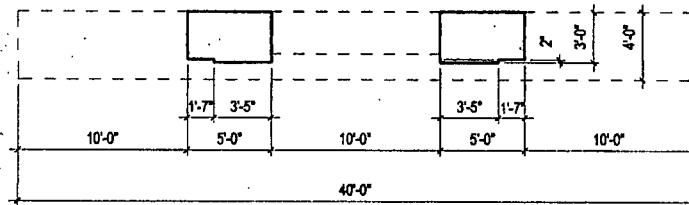
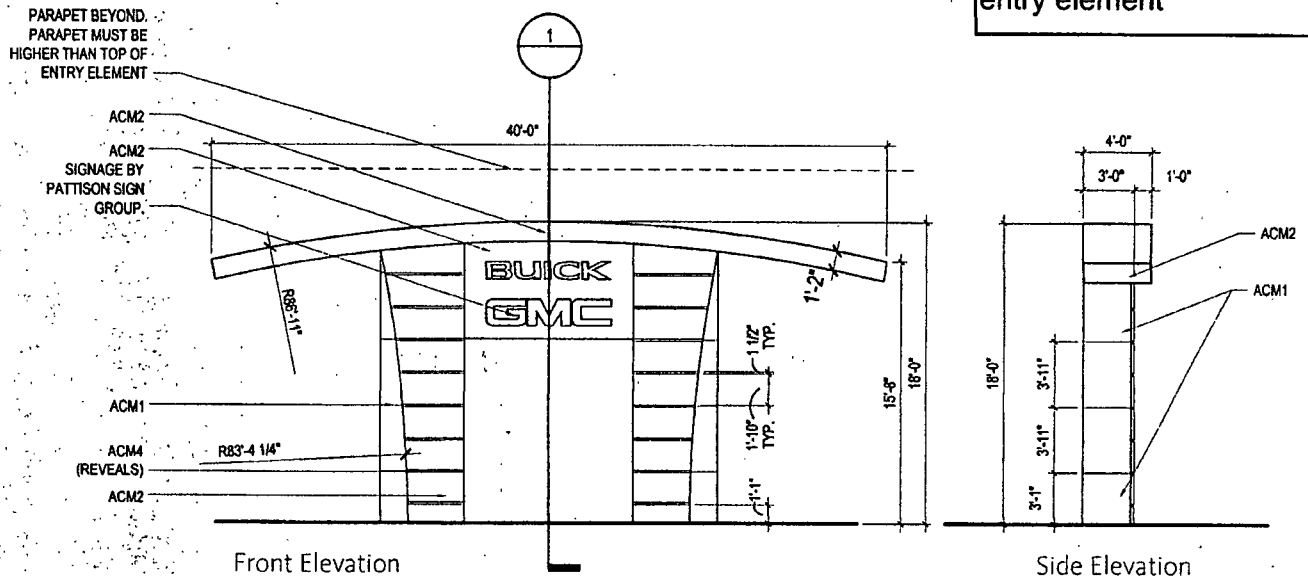

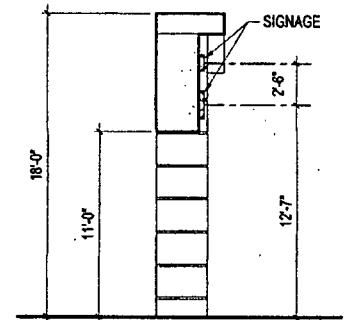

Provide Aluminum Composite Material (ACM) Panels over Exterior Sheathing and Light Gauge Metal Framing with 1/4" Typ. Joints

ACM 1: Match Alpolic #3-4TBL-G75 TBL Black (Locations: new ACM on Building Fascia, and new Entry Element column Box-Out front Wedge, Return and Back side of Column)

ACM 2: Match Alpolic #HLA-Brushed Hairline Aluminum (Location: New Entry Arch, Entry Center Feature, Front and Interior Panels)

ACM 3: Match Alpolic #RVW- White (Location: New ACM on Building Canopy)

ACM 4: Match Alpolic #3-4HPA-G80 High Polished Aluminum (Location: Inset on 1-1/2" Reveals on Front and Interior Panels)

Provide Tube Steel Columns and Steel Beams as required

Provide Recessed Downlights above Entry passageway and under Canopy
