**ORDINANCE**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the M1-1 Limited Manufacturing/Business Park District symbols and indications as shown on Map No. 3-J in the area bounded by

The public alley next north of and parallel to West Potomac Avenue; The Chicago, Milwaukee, St Paul and Pacific Railroad; a line 259.5 feet east of the east line of North Monticello Avenue; West Potomac Avenue; a line 90.0 feet east of the east line of North Monticello Avenue

to those of a C1-1 Neighborhood Commercial District.

SECTION 2. This ordinance takes effect after its passage and due publication.

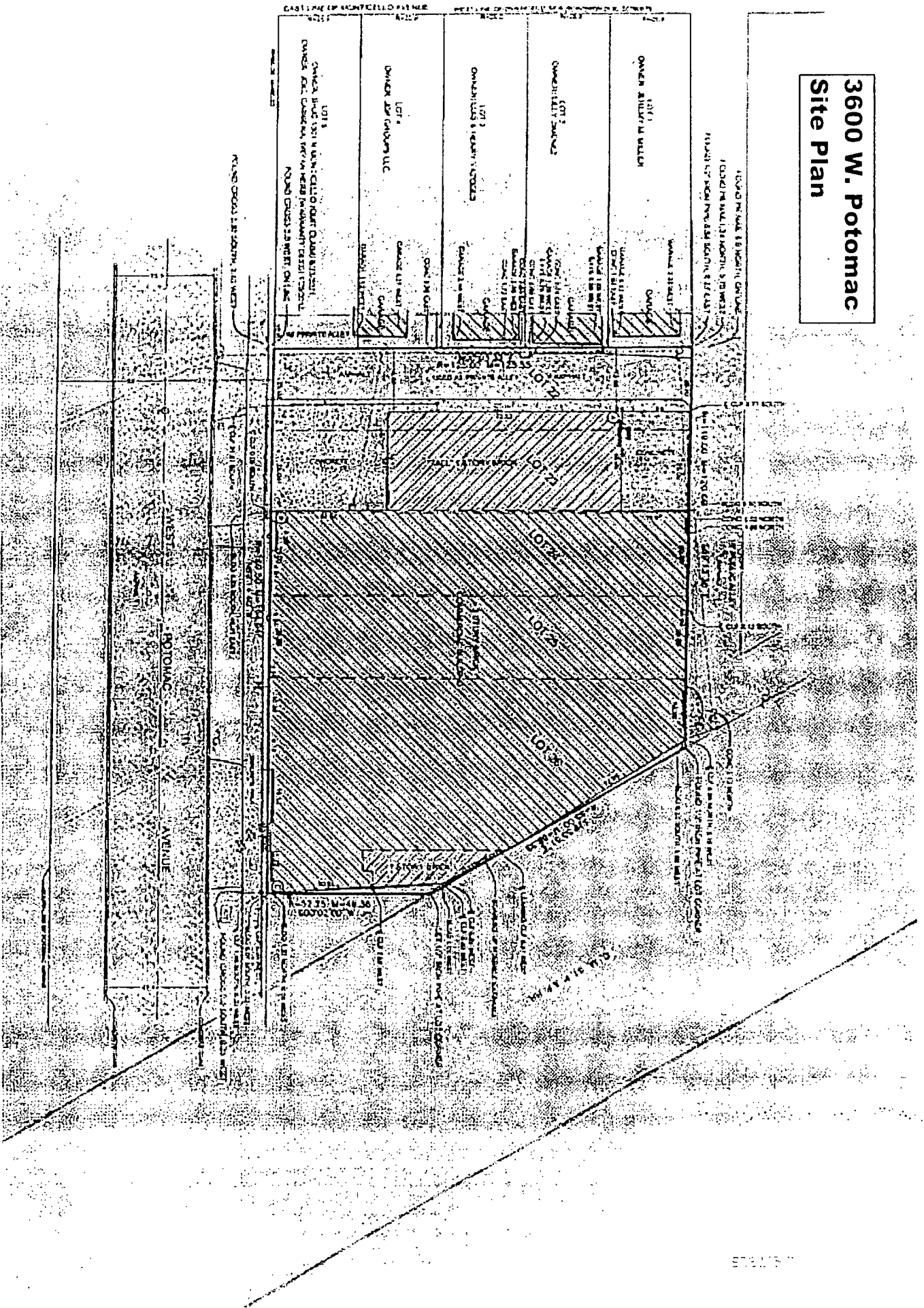

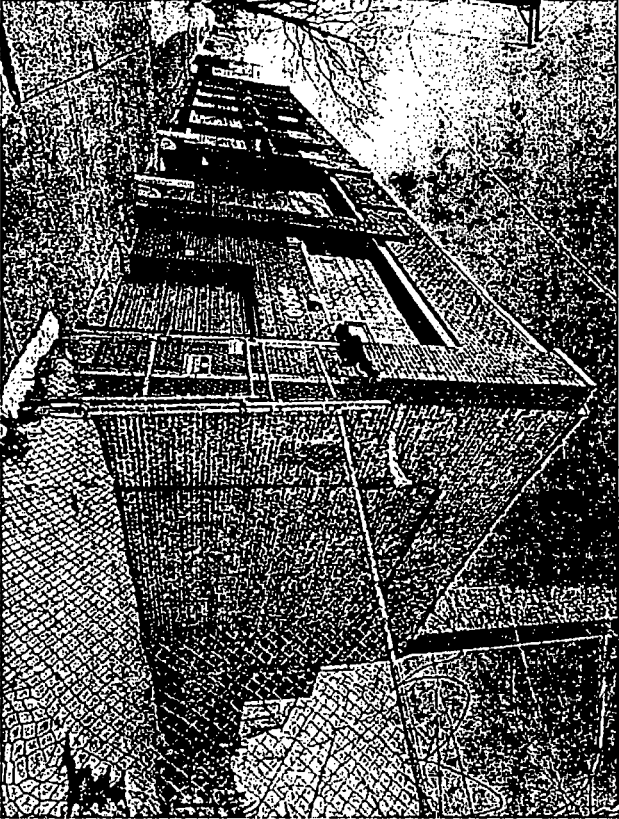

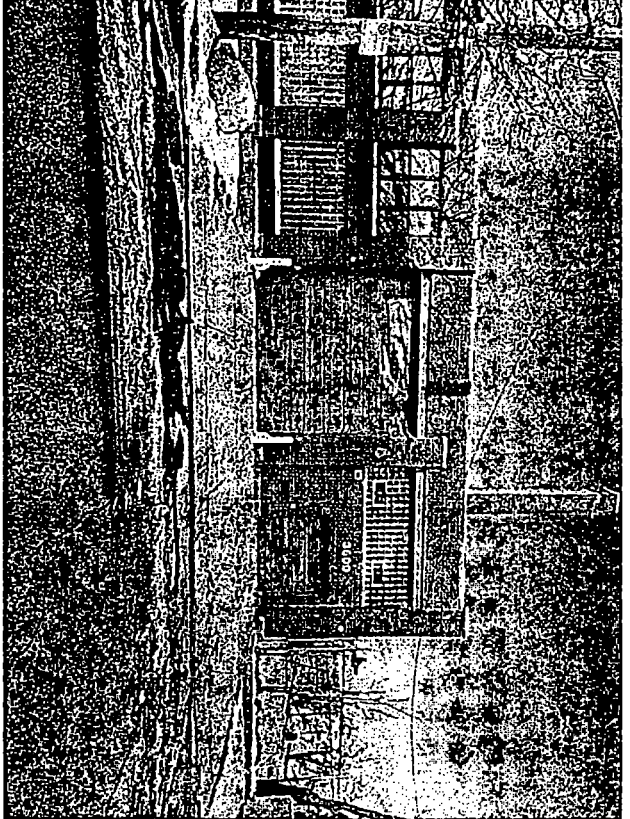

EAST ELEVATION

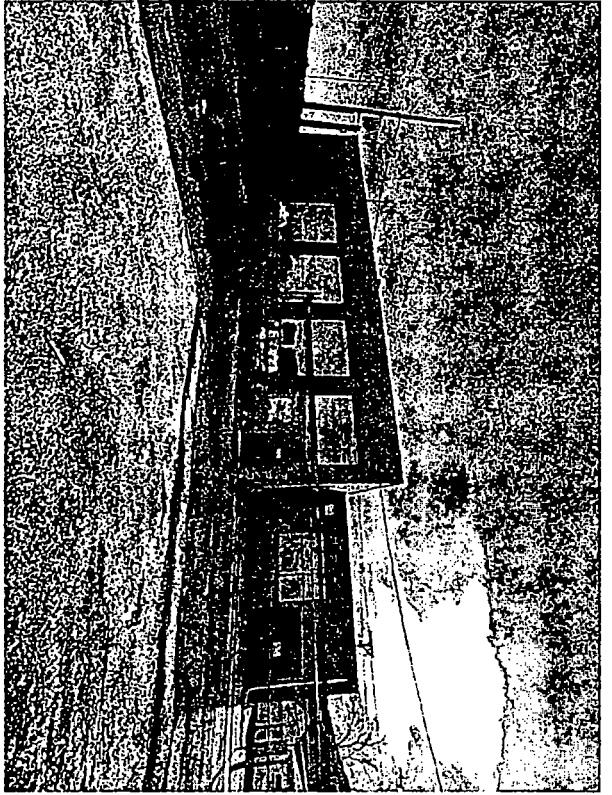


SOUTH ELEVATION

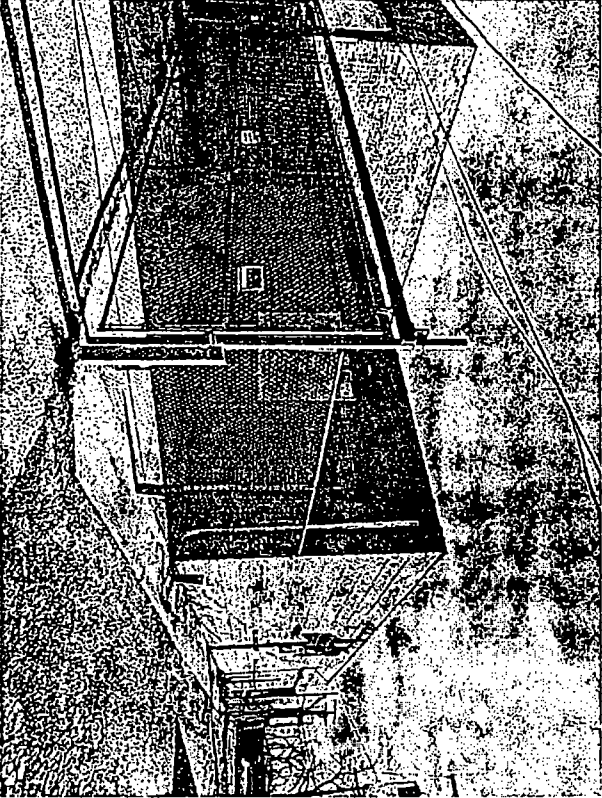


SOUTHEAST ELEVATION

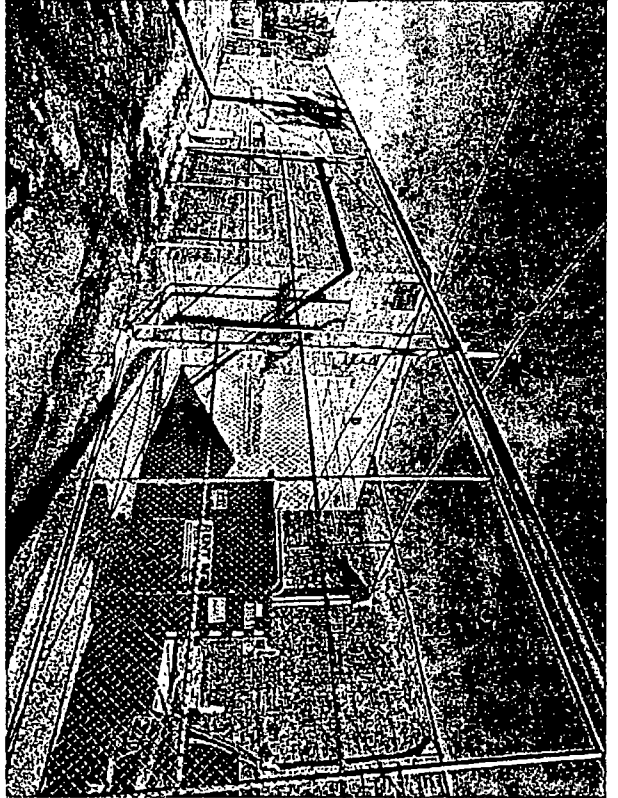

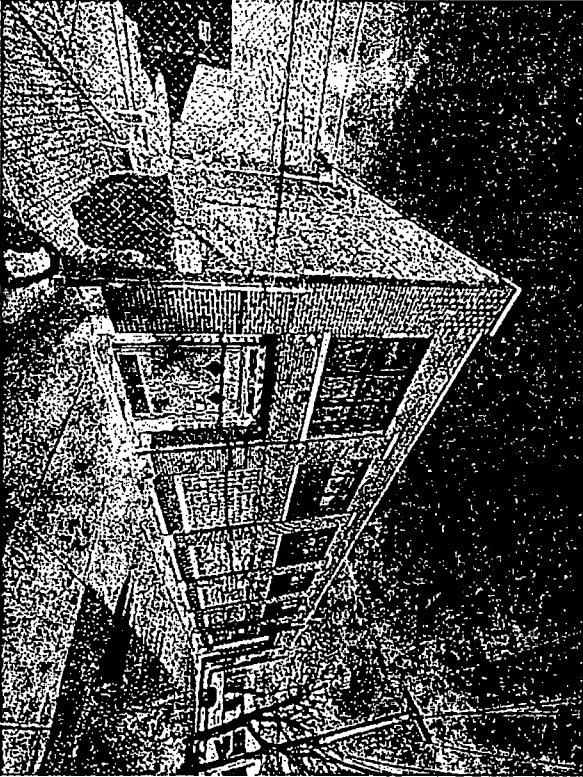


NORTH WEST ELEVATION

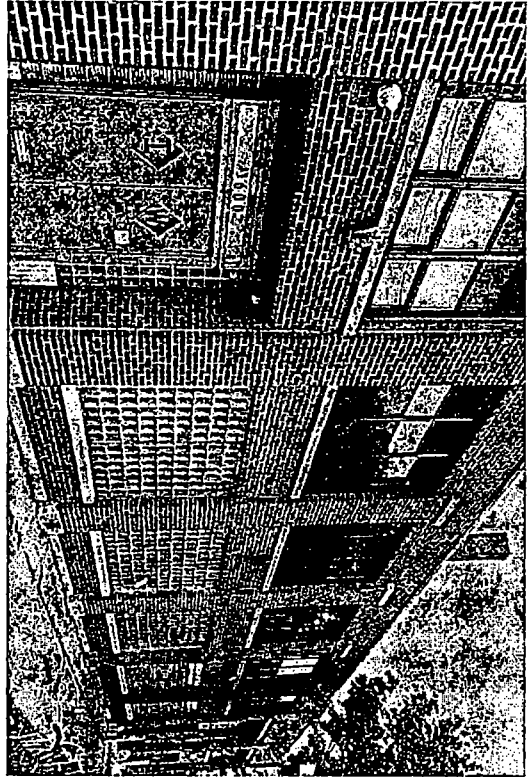

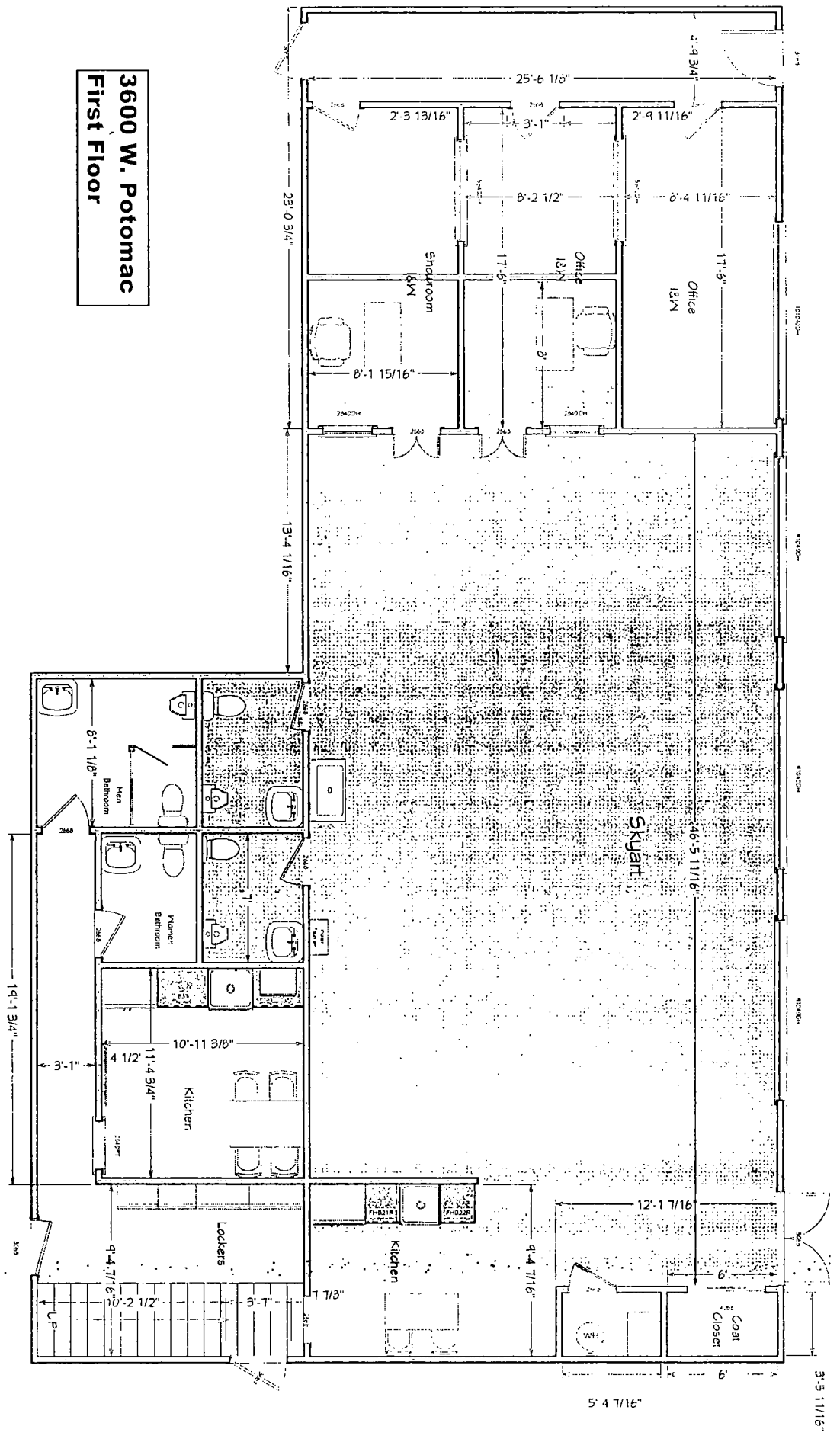

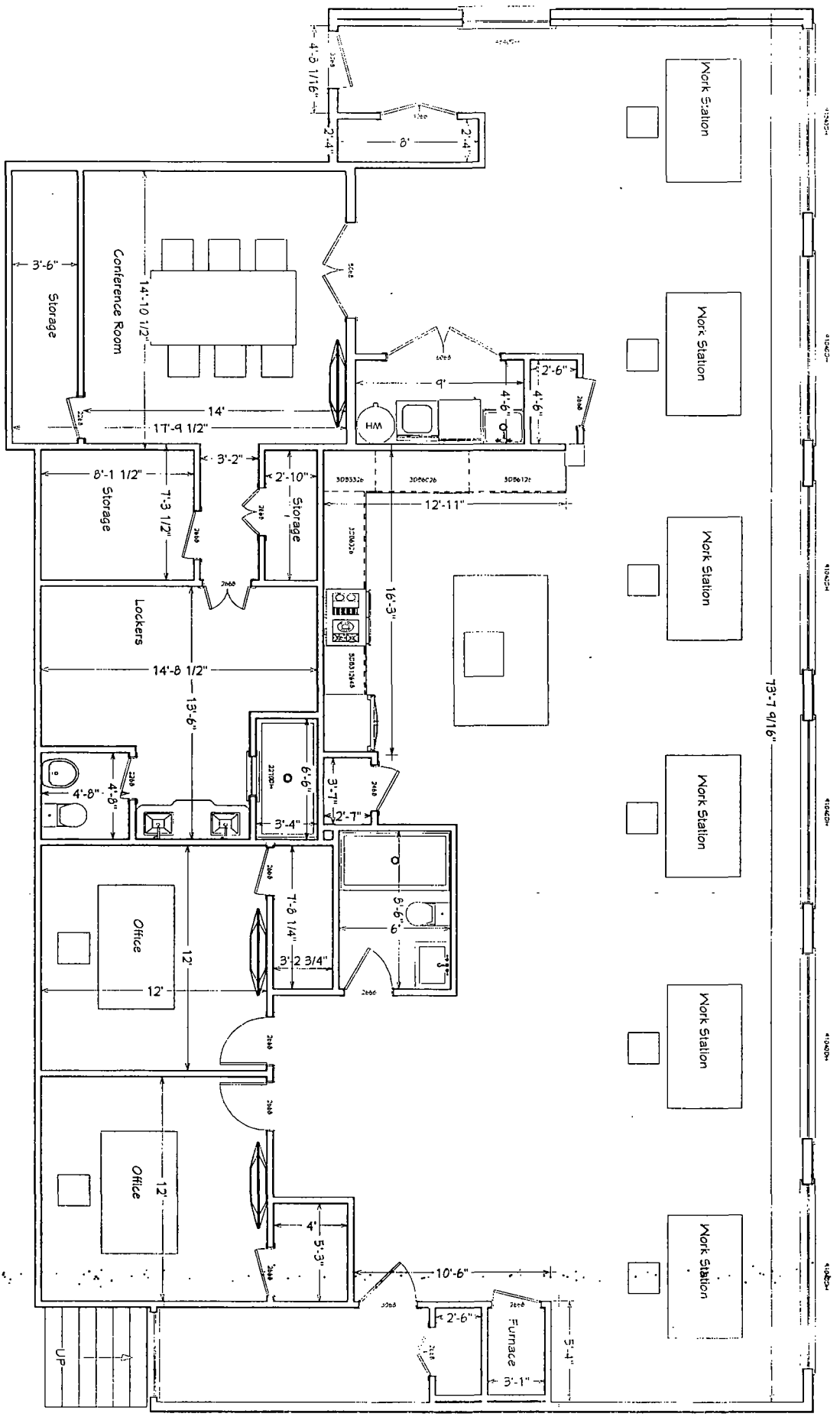
