31                North Kostner Avenue; North Kostner Avenue between West Diversey Avenue and West Belmont Avenue: Single Direction - Southerly. Not Recommended. 

- 19      South Homan Avenue; No Trucks Sign. Not Recommended: Duplicate proposal previously Passed 12/13/2017. Signs will be installed -- (17-08067817) [O2017-8366]
