James received an Associate Degree from Malcolm X College; a Certificate in Nonprofit Management from North Park University; and a Master of Arts Degree in Guidance and Counseling Psychology and a Bachelor of Arts Degree in Psychology graduating Summa Cum Laude from Chicago State University; and
