**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:**

**SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the RT4, Residential Two-Flat, Townhouse and Multi-Unit District symbols as shown on Map No. 5 - G in the area bounded by:**

**A line 200 feet South of and parallel to West Belden Avenue; North Halsted Street; a line 225 feet South of and parallel to West Belden Avenue; the public alley next West of and parallel to North Halsted Street.**

**To those of an RM4.5, Residential Multi-Unit District**

**SECTION 2. This Ordinance takes effect after its passage and due publication.**

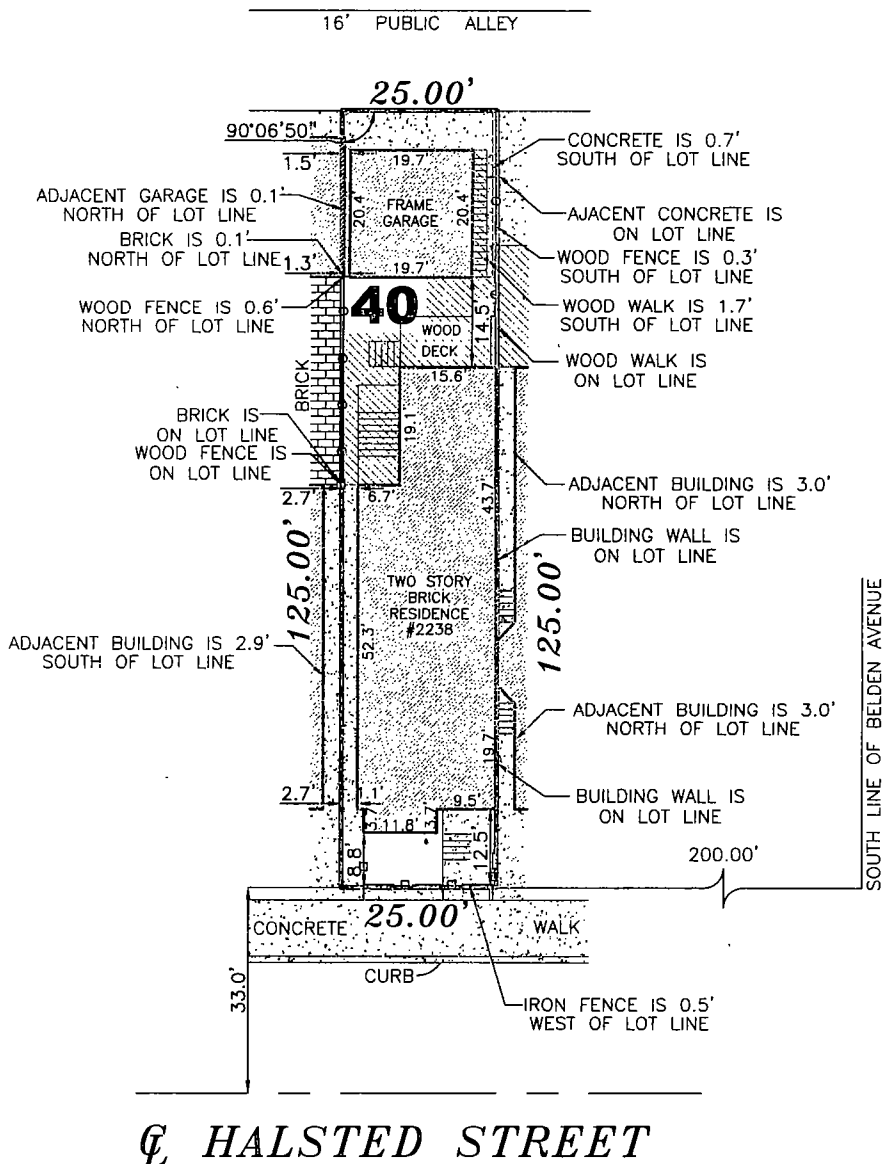
