

**SECTION 1.** Pursuant to Section 10-20-430 of the Municipal Code of Chicago, Commissioner of Transportation is hereby authorized and directed to exempt **Anton Webb of ATOWNCARS, Inc.**, from the provisions requiring barriers as a prerequisite to prohibit alley ingress and egress to **2045-2051 North Cicero Avenue**.


Dear Chairman Beale:
