Dear Committee Members:

I am the Executor of the Estate of Lavergne Wilson, the title holder to the property located at 2922 South Lowe. The estate would like to sell 2922 South Lowe but the lot is not a separate zoning lot from 2920 South Lowe. Due to the size of the existing home at 2920 South Lowe, separating the property into two zoning lots would create a non conforming use for 2920 South Lowe. In an effort to assist the estate, the owners of 2920 South Lowe have applied for a zoning amendment application to change the zoning of 2920 South Lowe from RS-3 to ~~RT-5~~ **RF-3.5**.
