U. S. GENERAL SERVICES ADMINISTRATION

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to U. S. GENERAL SERVICES ADMINISTRATION, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, two (2) Occupation of Space for two (2) pop-up vehicle barriers on the public right-of-way for security purposes for the Ralph Metcalfe Building adjacent to its premises known as 77 W. Jackson Blvd.. Existing security barriers consist of two (2) hydraulic pop-up heavy steel plate vehicle barriers on the south and north ends of the alley that separates the Metcalfe Federal Building on the west and the Union League Club on the east. Existing public alley between Jackson Boulevard and Van Buren Street measure four hundred ten (410) feet in length and Twelve (12) feet in width.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development, Department of Transportation (Division of Project Development), and Department of Transportation (Office of Underground Coordination).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1101870 herein granted the sum of zero (\$.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

Authority herein given and granted for a period of five (5) years from and after 02/27/2012.
