
Ordered, That the Commissioner of the Department of Buildings is hereby directed to issue a sign permit to Icon Identity Solutions, 1418 Elmhurst Road, Elk Grove Village, IL 60007 for the erection of a sign/signboard over 24 feet in height and/or 100 square feet (in area of one face) at LA Fitness, 7529 North Clark Street:

Dimensions: length, 32 feet -4 $\frac{1}{2}$ inches; height, 3 feet – 6 inches

Height above Grade/Roof to Top of Sign: 22 feet


Total Square Foot Area: 113 square feet

To be legal, such sign(s) shall comply with all applicable provisions of Title 17(the Chicago Zoning Ordinance) and all other applicable provisions of the Municipal Code of the City of Chicago governing the construction and maintenance of outdoor signs, signboards and structures.






