ORDINANCE ELEPHANT & CASTLE Acct. No. 308424 - 1 Permit No. 1095221

Be It Ordained by the City Council of the City of Chicago:

Permission and authority are hereby given and granted to ELEPHANT & CASTLE upon the terms and subject to the conditions of this ordinance, to maintain and use a portion of the public right of way for a sidewalk cafe adjacent to its premises located at 185 N. Wabash Ave.. Said sidewalk cafe area #1 shall be thirty-five point three three (35.33) feet in length and eight (8) feet in width, area #2 shall be six (6) feet in length and eight (8) feet in width, area #3 shall be eighteen point seven five (18.75) feet in length and five point four two (5.42) feet in width, area #4 shall be fourteen point five (14.5) feet in length and nine point one seven (9.17) feet in width, area #5 shall be fifty-three point two five (53.25) feet in length and eleven point one seven (11.17) feet in width for a total of one thousand one hundred sixty point zero three (1160.03) square feet and shall allow six (6) feet of clear space from the face of the curb/building line along W. Lake Street, and N. Wabash Avenue. The compensation for said space and the days and hours of operation for the sidewalk cafe shall be as follows:

Monday through Saturday 11:00 a.m. to 11:00 p.m. Sunday 11:00 a.m. to 10:00 p.m. Compensation: \$5,220.15

SEATING CAPACITY: 68

Sidewalk Cafe Permit and approved plan must be posted at all times.

* Sidewalk Cafes shall not operate earlier than 8:00 AM, nor later than 11:00 PM.

This grant of privilege #1095221 for a sidewalk cafe shall be subject to the provisions of Section 10-28-900 though 10-28-995 of the Municipal Code of Chicago and the directions of the Commissioner of Department of Business Affairs and Consumer Protection, the Commissioner of Streets and Sanitation, and the Commissioner of Transportation.




Authority for the above named privilege is herein given and granted from and after March 1, 2011 through and including December 1, 2011.
