BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:


SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning
Ordinance is hereby amended by changing all of the B1-2, Neighborhood Shopping
District symbols as shown on Map No. 7-N
in the area bounded by:

The public alley next North of and parallel to West Grand Avenue; a line 127.95 feet
Northwest of and almost parallel to North Neva Avenue (as measured along the
Northern boundary line of Grand Avenue); West Grand Avenue; a line 177.95 feet
Northwest of and almost parallel to North Neva Avenue (as measured along the
Northern boundary line of Grand Avenue)

To those of a C1-2, Neighborhood Commercial District

SECTION 2. This Ordinance takes effect after its passage and approval.
