*Be It Ordained by the City Council of the City of Chicago:*

SECTION 1. Permission and authority are hereby given and granted to LUX, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, two (2) Canopy(s) projecting over the public right-of-way adjacent to its premises known as 5237-41 N. Harlem Ave.

Said Canopy(s) at N. Harlem measure(s):

One (1) at nineteen point six six (19.66) feet in length, and three point six six (3.66) feet in width for a total of seventy-one point nine six (71.96) square feet.

Said Canopy(s) at N. Harlem measure(s):

One (1) at thirty-nine point five eight (39.58) feet in length, and four point five (4.5) feet in width for a total of one hundred seventy-eight point one one (178.11) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department - Signs

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1131195 herein granted the sum of one hundred fourteen dollars and fifty-eight cents (\$114 58) per annum in advance


A 25% penalty will be added for payments received after due date


