

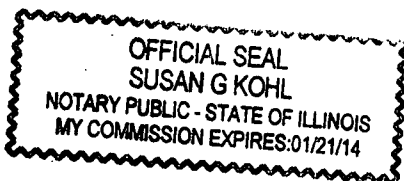



(hereafter the "Property") will be filed on or about April 10, 2012 with the Department of Housing and Economic Development, City of Chicago by 1815 W. Division, LLC, 400 West Huron Street, Chicago, Illinois 606054 (hereinafter the "Applicant"). The addresses that correspond to the Property are 1811-1825 West Division Street and 1141-1157 North Honore Street, Chicago, Illinois. The Applicant is the owner of the Property.

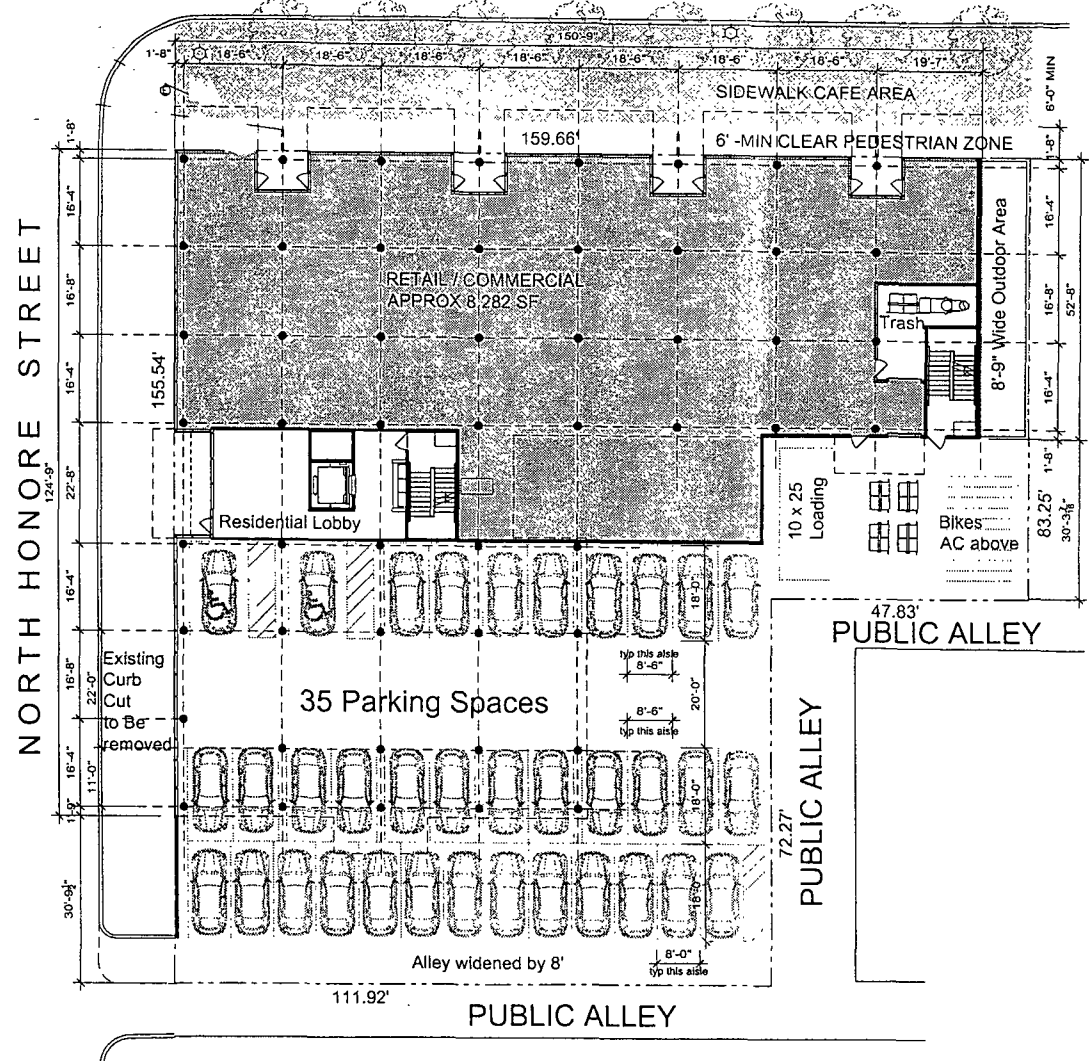

Ground Floor Plan

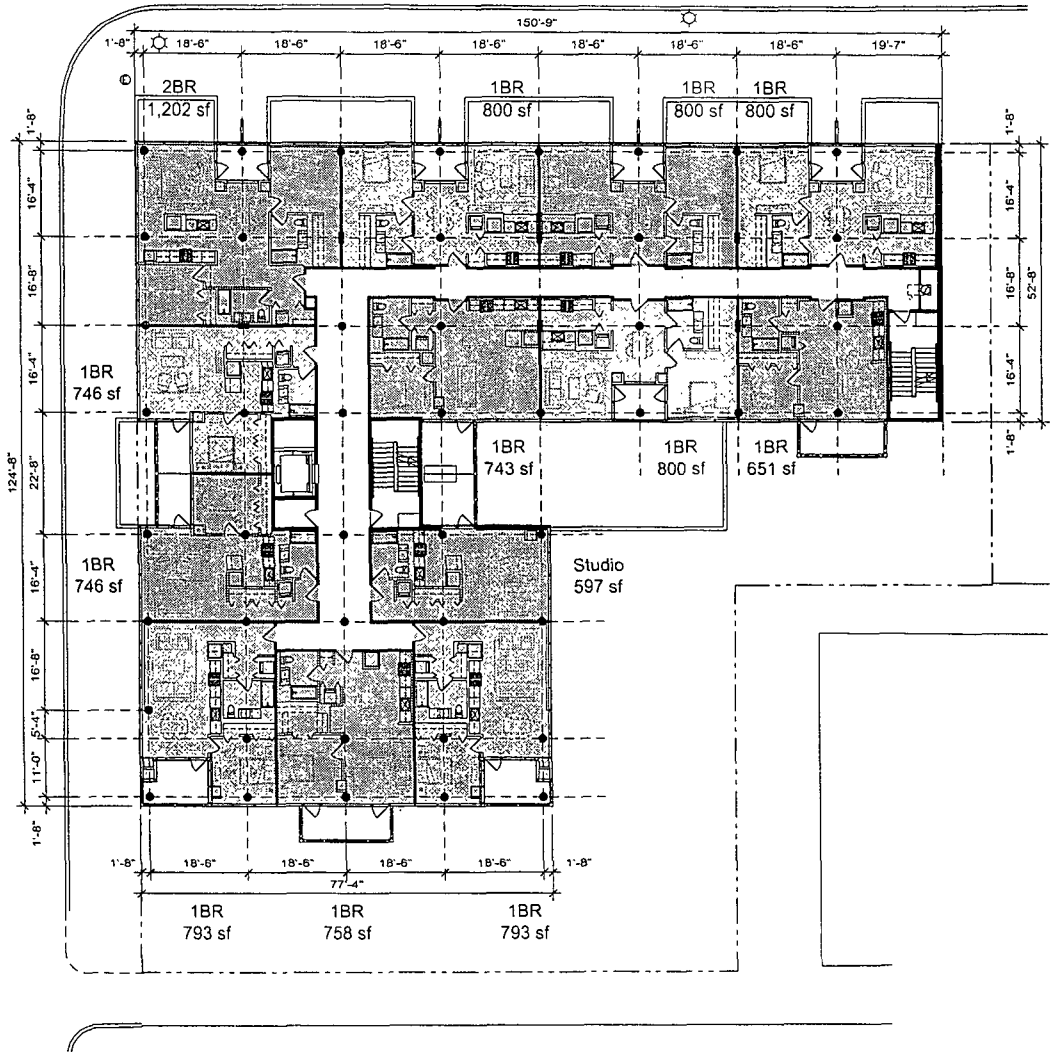

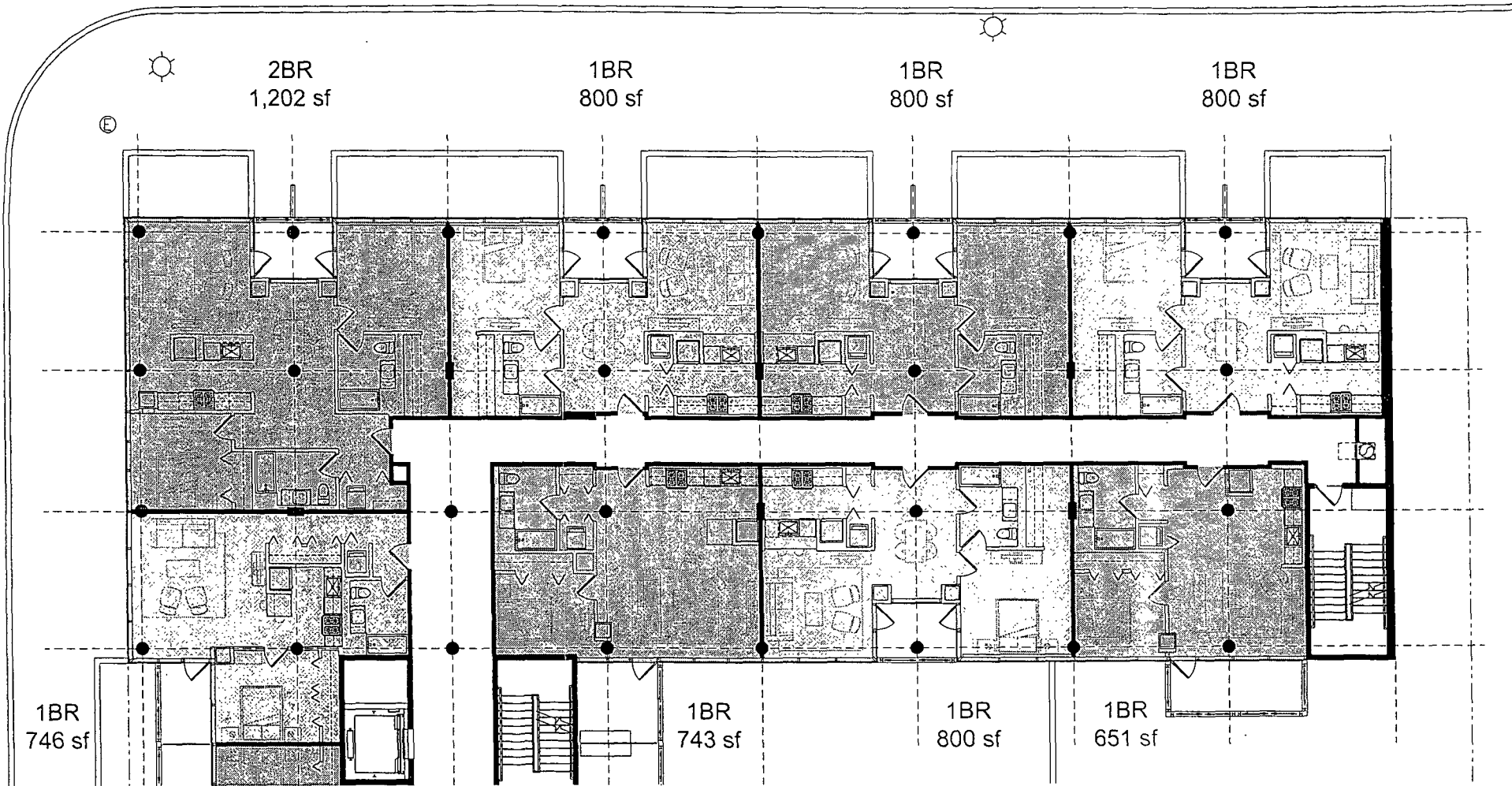

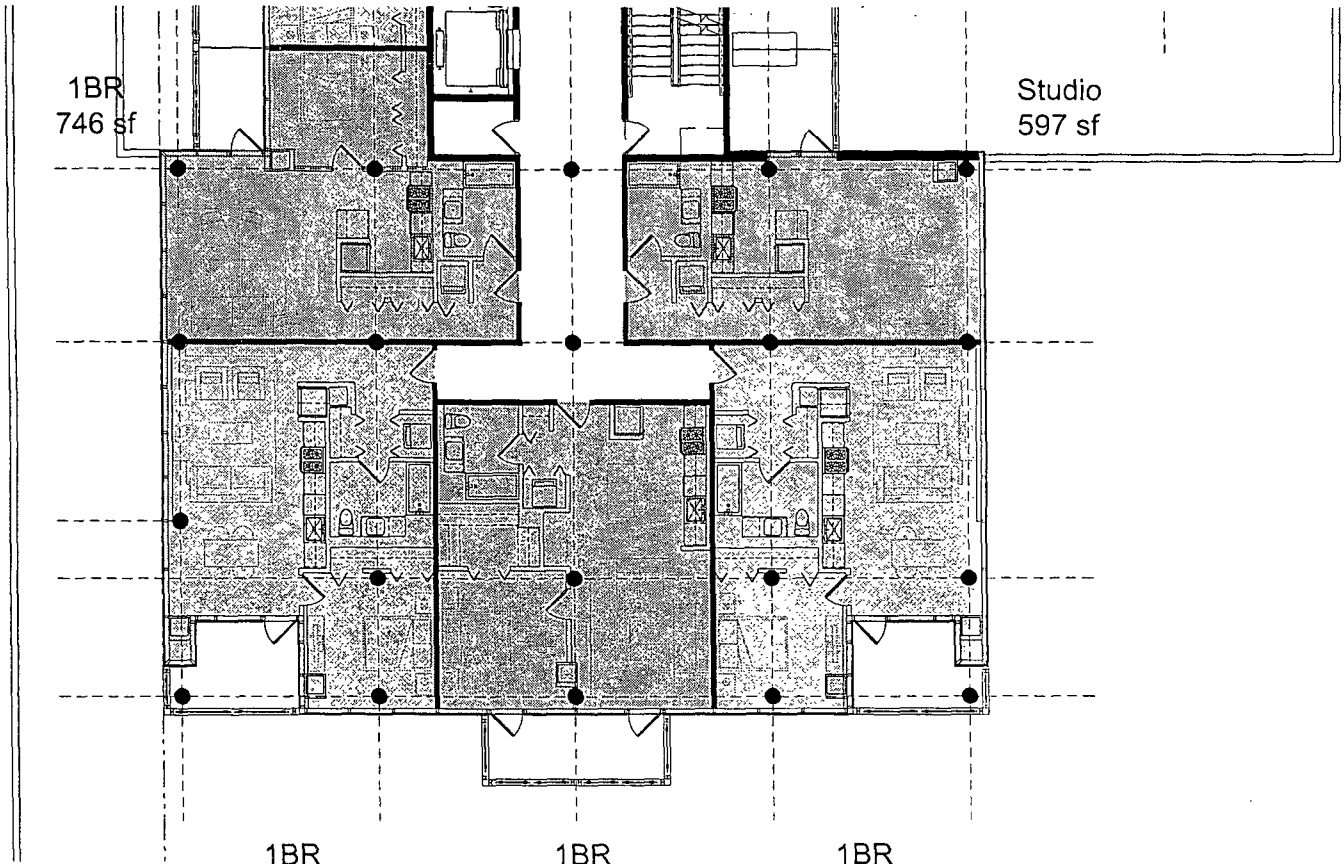


North Unit Plans 1

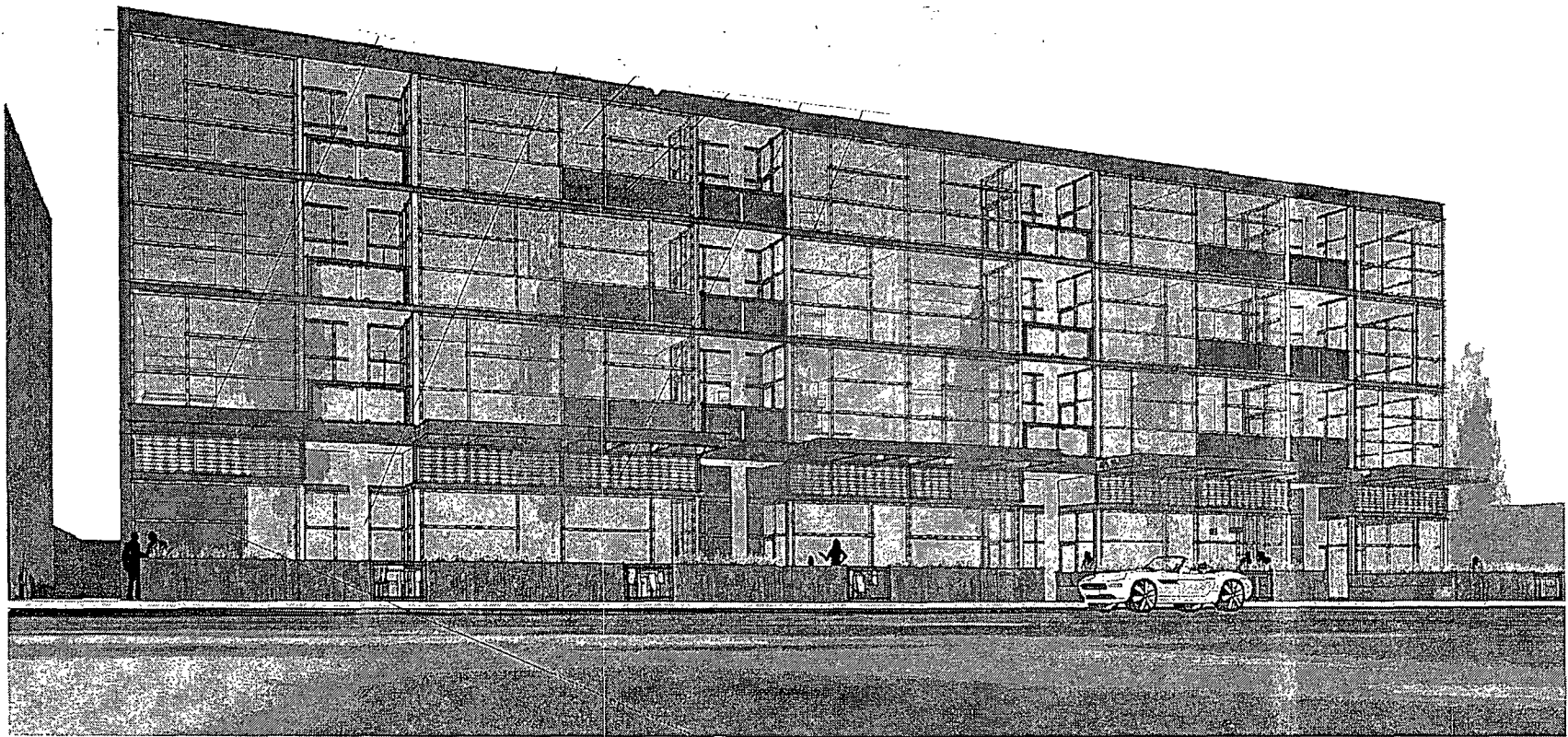

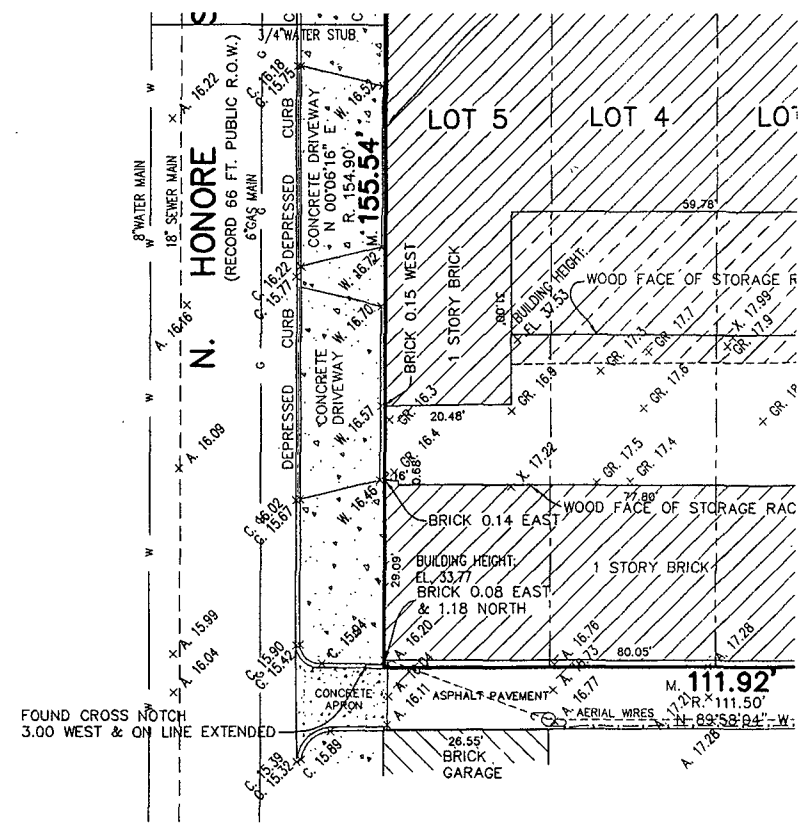

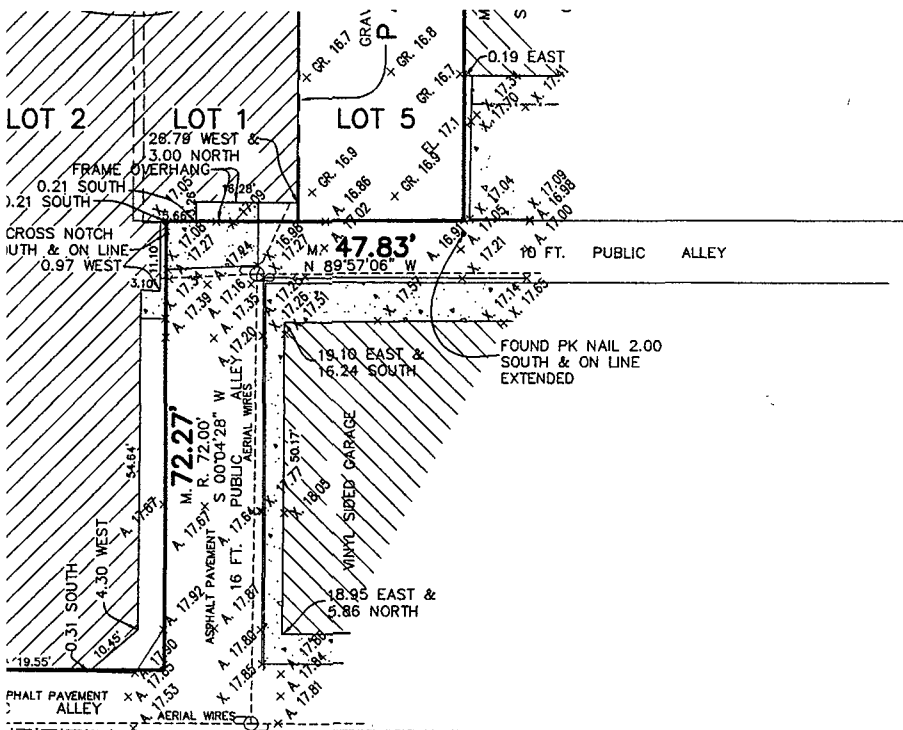
