ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the M1-2, Limited Manufacturing/Business Park District symbols as shown on Map No. 22-B in the area bounded by:

East 87th Street; the Baltimore and Ohio Railroad; East 88th Street; and South Baltimore Avenue.

To those of an M3-2 Heavy Industry District

SECTION 2. This Ordinance takes effect after its passage and due publication.
