ORDINANCE QUAKER TOWER Acct. No. 458344 - 1 Permit No. 1140089

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to QUAKER TOWER, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, one (1) Canopy(s) projecting over the public right-of-way adjacent to its premises known as 555 W. Monroe St..

Said Canopy(s) at W. MONROE STREET measure(s):

One (1) at forty-five (45) feet in length, and twenty (20) feet in width for a total of nine hundred (900) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1140089 herein granted the sum of seventy (\$70.00) per annum in advance.

A 25% penalty will be added for payments received after due date.



Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to NECESSARY & SUFFICIENT COFFEE, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use one (1) Security Camera(s) projecting over the public right-of-way for security purposes adjacent to its premises known as 3624 W. Wrightwood Ave..

Said Security Camera(s) at N. Monticello measure(s):

One (1) at point four two (.42) feet in length, point six seven (.67) feet in width and eight point two three (8.23) feet above grade level.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development and Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1140793 herein granted the sum of zero (\$.00) per annum in advance.


