ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1: Title 17 of the Municipal Code of Chicago, Chicago Zoning Ordinance, is amended by changing all the B1-2 Neighborhood Shopping District symbols and indications as shown on Map No. 14-D in the area bounded by:

East 57th Street;

A line 100 feet west of and parallel to South Kenwood Avenue;

The public alley next south of and parallel to East 57th Street;

A line 125 feet west of and parallel to South Kenwood Avenue

to those of a B3-2 Community Shopping District, which is hereby established in the area described.

SECTION 2: This ordinance shall take effect upon its passage and due publication.

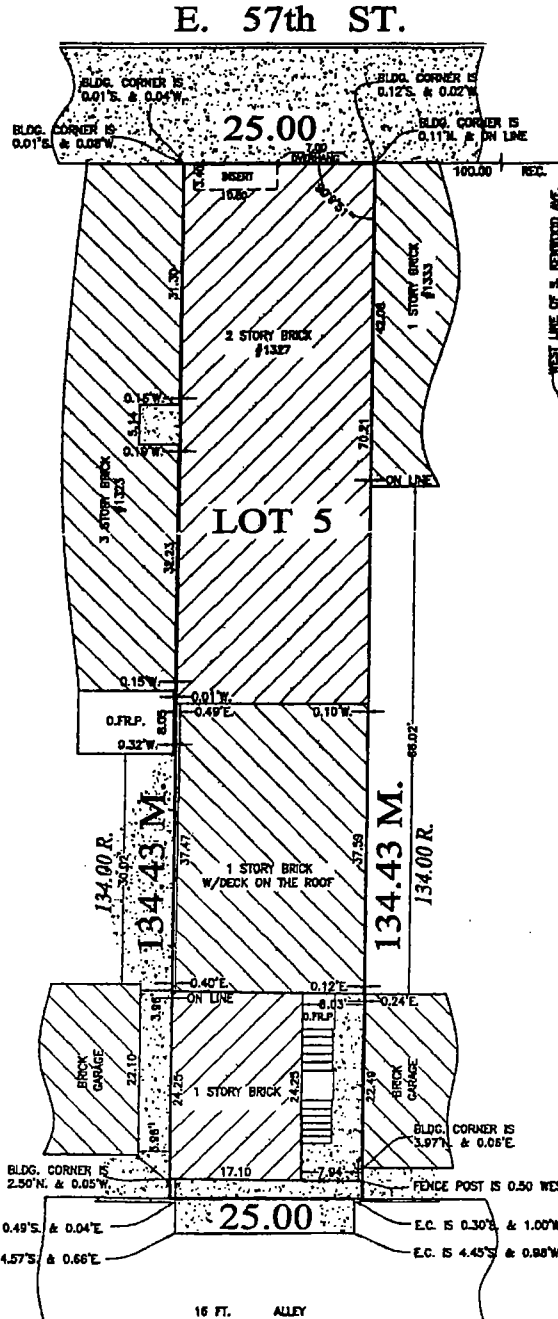

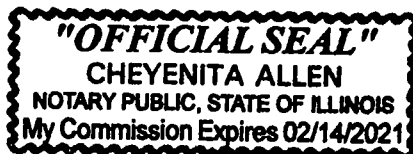
