BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the RS3 Residential Single-Unit (Detached House) District symbols as shown on Map No. 1-M in the area bounded by:

A line 76 feet south of and parallel to West Fulton Street; the alley next east of and parallel to North Menard Avenue; a line 126 feet south of and parallel to West Fulton Street; and North Menard Avenue.

To those of an RT4 Residential Two-Flat, Townhouse and Multi-Unit District

SECTION 2. This Ordinance takes effect after its passage and due publication.
