TRAFFIC LANE – TOW ZONES

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Pursuant to Title 9, Chapter 64, of the Municipal Code of Chicago, the following locations are hereby designated as Traffic Lane – Tow Zones, between the limits and during the times specified, standing or parking of any vehicle shall be considered a definite hazard to the normal movement of traffic:

WARD TOW ZONES:

- 25 West Arthington Street; West Arthington Street (south side) from South Aberdeen Street to South Carpenter Street; No Parking Tow Zone, All Times, All Days [O2016-4596]
- 31 North Kenton Avenue; North Kenton Avenue (east side) from West Fullerton Avenue to West Diversey Avenue; No Parking Tow Zone, All Times, All Days -- (16-02158452) [O2016-1031]
- 33 West Leland Avenue; West Leland Avenue (north side) from North Kedzie Avenue to the first alley east thereof; No Parking Tow Zone, All Times, All Days -- (16-03255476) [O2016-3295]
- 41 6548-6542 West Hurlbut Street; West Hurlbut Street (north side) from North Northcott Avenue to a point 234 feet west thereof; No Parking Tow Zone, 7:00am to 10:00am and 2:00pm to 4:00pm, School Days -- (16-02131261) [Or2016-84]
- 42 East Ontario Street; East Ontario Street (south side) from a point 170 feet east of North Fairbanks Street to North McClurg Court; No Parking Tow Zone, 4:00pm to 6:00pm, Monday through Friday -- (15-03298586) [O2015-5200]
- 50 North California Avenue; North California Avenue (east side) from a point 27 feet north of West Rosemont Avenue to a point 80 feet north thereof; No Parking Tow Zone, 8:00am to 4:30pm, Sunday through Friday -- (16-02287622) [O2016-3331]
