## ORDINANCE

***BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:***

***SECTION 1.*** Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the RT4 Residential Two-Flat, Townhouse and Multi-Unit District symbols and indications as shown on Map No.3-H in the area bounded by

a line 316.27 feet north of and parallel to West Chicago Avenue;  
the alley next east of and parallel to North Damen Avenue; a line  
291.67 feet north of and parallel to West Chicago Avenue; and  
North Damen Avenue,

to those of a RM5 Residential Multi-Unit District and a corresponding uses district is hereby established in the area above described.

***SECTION 2.*** This ordinance shall be in force and effect from and after its passage and due publication.

In accordance with Amendment to the Zoning Code enacted by the City Council, Section 17-13-0107-A, please be informed that on or about **November 29, 2018**, I, the undersigned, intend to file an application for a change in zoning from an RT-4 Residential Two-Flat, Townhouse, and Multi-Unit District to an RM-5 Residential Multi-Unit District, on behalf of the Applicant/Owner – 831 North Damen Homeowners Association, for the property located at **831 North Damen Avenue, Chicago, Illinois**.

The existing three-and-a-half-story (with basement) residential building, which is situated along the north property line and measures more than 38 feet-0 inches in height, presently contains six (6) dwelling units.
