West Van Buren Street; a line 31.12 feet east of and parallel to South Laverne Avenue; the alley next south of and parallel to West Van Buren Avenue; and South Laverne Avenue,

to those of a B2-2 Neighborhood Mixed-Use District and a corresponding uses district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
