**ORDINANCE**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:**

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B1-2 Neighborhood Shopping District symbols and indications as shown on Map No. 18-F in the area bounded by

A line 98.65 feet north of and parallel to West 74<sup>th</sup> Street;  
the public alley next east of and parallel to South Halsted Street;  
a line 48.65 feet north of and parallel to West 74<sup>th</sup> Street;  
and South Halsted Street.

to those of a C2-1 Motor Vehicle-Related Commercial District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
