WELLS STREET MARKET

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to WELLS STREET MARKET, upon the terms and subject to the conditions of this ordinance to maintain and use three (3) sign(s) projecting over the public right-of-way attached to its premises known as 205 W. Wacker Dr..

Said sign structure(s) measures as follows; along N. WELLS STREET:

One (1) at twelve point one seven (12.17) feet in length, one point eight three (1.83) feet in height and ten (10) feet above grade level.

One (1) at one point five (1.5) feet in length, four (4) feet in height and ten (10) feet above grade level.

Said sign structure(s) measures as follows; along W Wacker Dr:

One (1) at thirteen point six seven (13.67) feet in length, two (2) feet in height and ten (10) feet above grade level.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development) and Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.


The grantee shall pay to the City of Chicago as compensation for the privilege #1134466 herein granted the sum of four hundred seventy-five (\$475.00) per annum in advance.

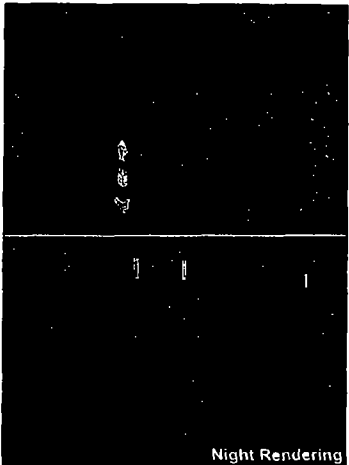
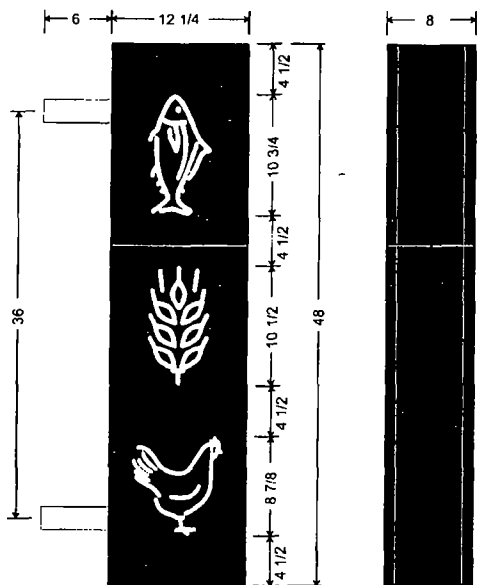
A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

Authority herein given and granted for a period of five (5) years from and after Date of Passage.

Fabricated aluminum tube frame cabinet, double sided aluminum panels with routed and pushed thru graphics 1/2" translucent white acrylic (1/4" exposed)

Internally illuminated with white LED 4000K lighting mounted to aluminum trays secured to internal structure

Internal plates for field welding mounting steel supports with welded plates for corner mounting to stone building. Exact hardware and plate size TBD based on engineering

Internal power supplies located at bottom of cabinet with access panel. Electrical service brought to sign by others
