MUSEUM OF BROADCAST COMMUNICATION

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to MUSEUM OF BROADCAST COMMUNICATION, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, two (2) Concrete and Metal Facia/Cladding(s) projecting over the public right-of-way adjacent to its premises known as 360 N. State St..

Said Concrete and Metal Facia/Cladding(s) at W. KINZIE measure(s):

One (1) at twelve (12) feet in length, and one hundred forty-one (141) feet in width for a total of one thousand six hundred ninety-two (1692) square feet.

One (1) at forty-one (41) feet in length, and one hundred forty-one (141) feet in width for a total of five thousand seven hundred eighty-one (5781) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1139251 herein granted the sum of four thousand nine hundred two (\$4,902.00) per annum in advance.


A 25% penalty will be added for payments received after due date.

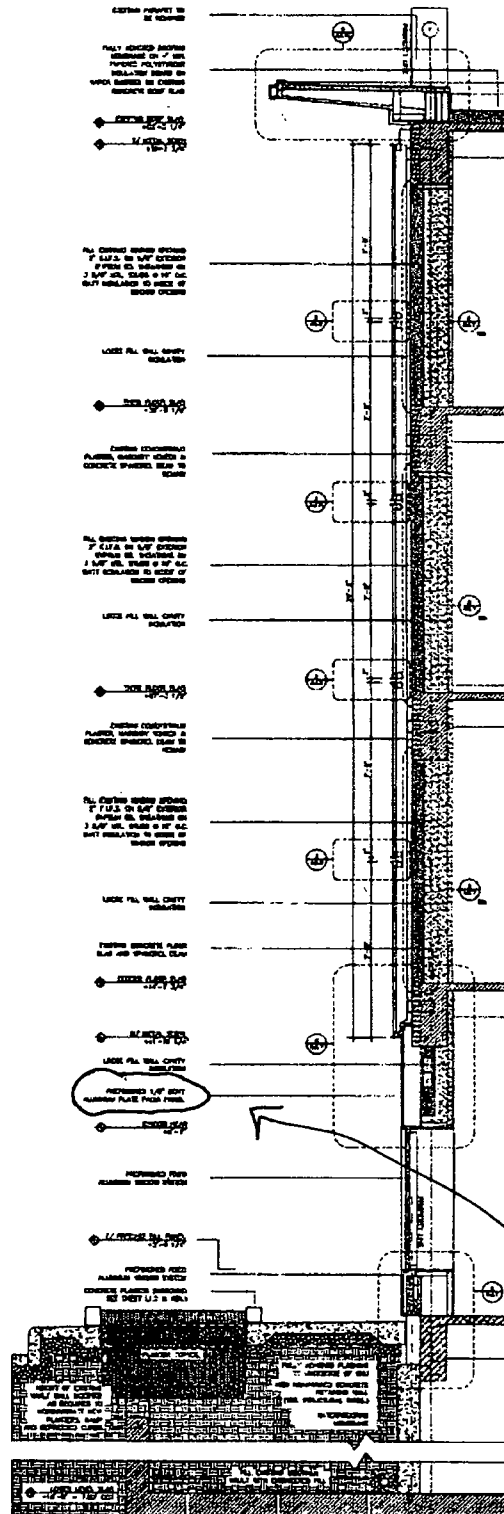
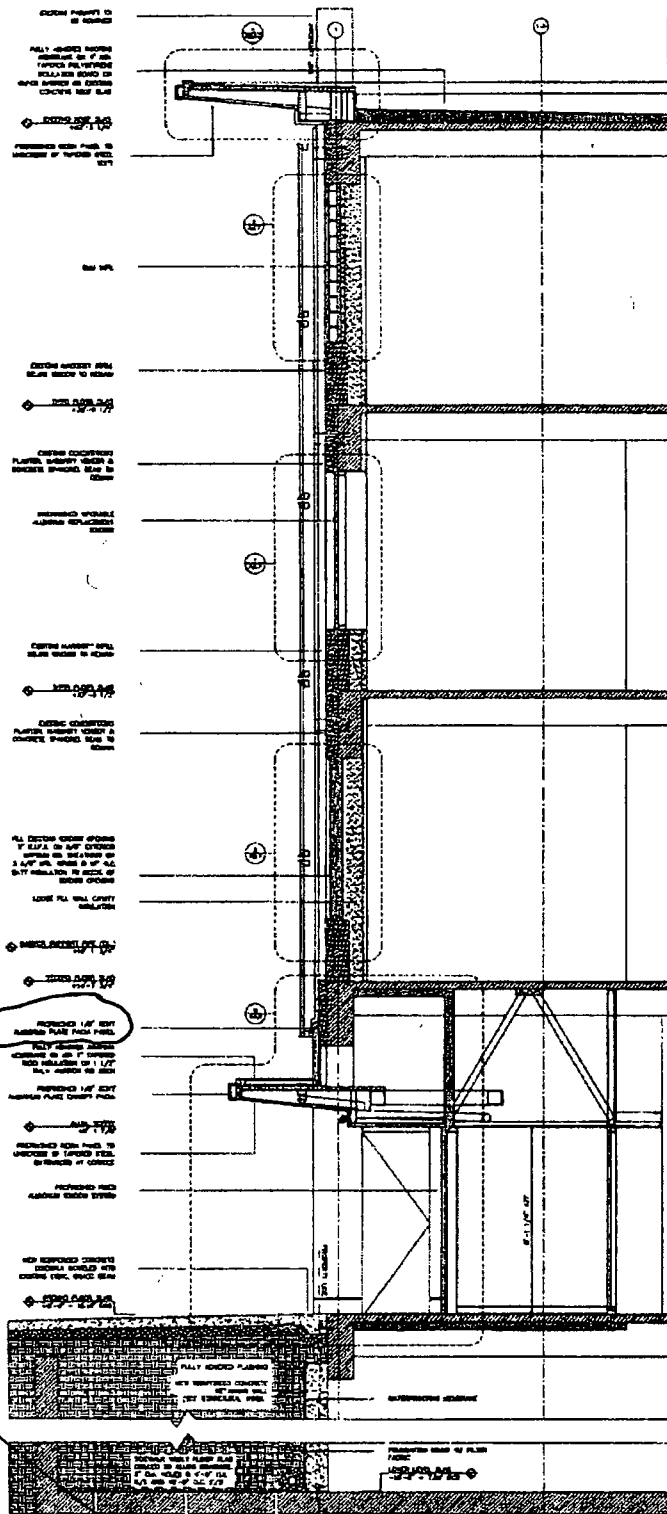
