Be It Ordained by the City Council of the City of Chicago:

Permission and authority are hereby given and granted to QUAY upon the terms and subject to the conditions of this ordinance, to maintain and use a portion of the public right of way for a sidewalk cafe adjacent to its premises located at 465 E. Illinois St.. Said sidewalk cafe area #1 shall be thirty-one point six two (31.62) feet in length and ten point five eight (10.58) feet in width, area #2 shall be twenty-eight point eight seven (28.87) feet in length and ten point five eight (10.58) feet in width for a total of six hundred thirty-nine point nine eight (639.98) square feet and shall allow six (6) feet of clear space from the face of the curb/building line along E ILLINOIS ST. The compensation for said space and the days and hours of operation for the sidewalk cafe shall be as follows:

Saturday through Sunday 8:00 a.m. until 11:00 p.m.

Compensation: \$1,471.96

SEATING CAPACITY: 56

Sidewalk Cafe Permit and approved plan must be posted at all times.

This grant of privilege #1097565 for a sidewalk cafe shall be subject to the provisions of Section 10-28-900 through 10-28-995 of the Municipal Code of Chicago and the directions of the Commissioner of Department of Business Affairs and Consumer Protection, the Commissioner of Streets and Sanitation, and the Commissioner of Transportation.


