**West Cortland Street; North California Avenue; a line 50 feet South of and parallel to West Cortland Street; the public alley next West of and parallel to North California Avenue.**

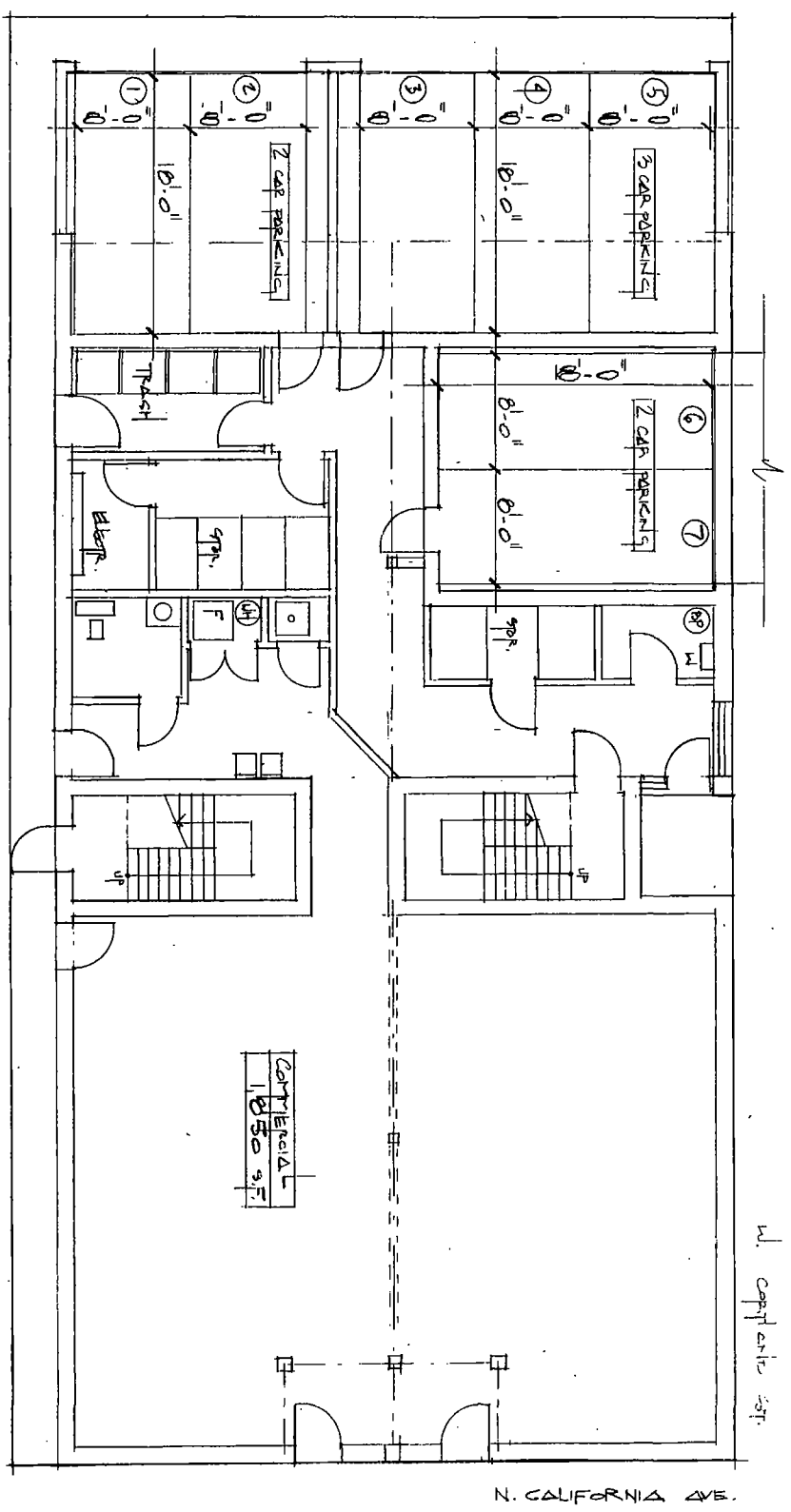

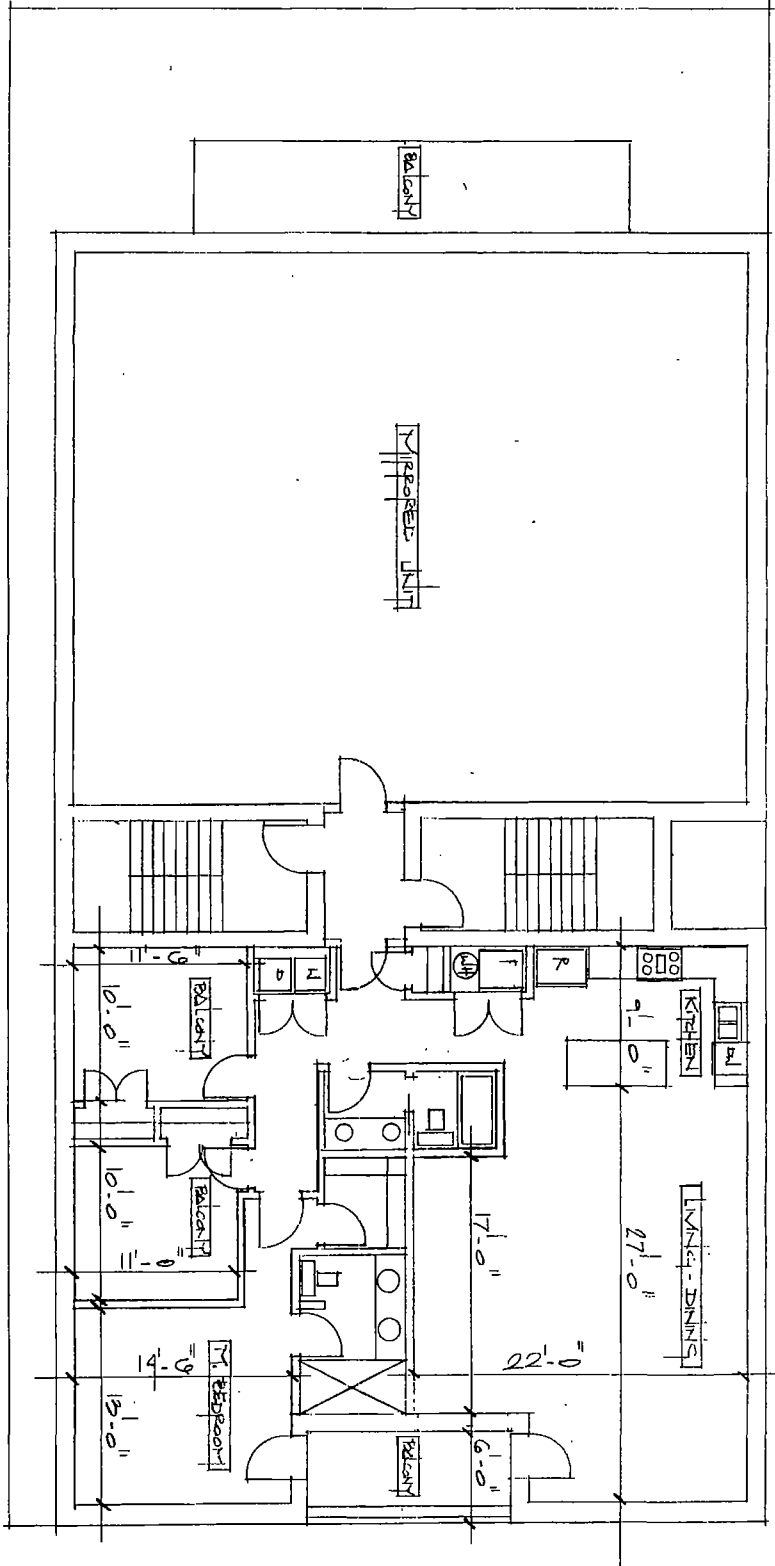
3<sup>rd</sup> Floor Plan
