

**LOADING ZONES:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:**

**SECTION 1.** Pursuant to Title 9, Chapter 64, Section 160, of the Municipal Code of Chicago, the following locations are hereby designated as loading zones for the distances specified, during the hours specified:

1	N. Rockwell Street (east side) from a point 20 feet north of W. Diversey Avenue to a point 60 feet north thereof, No Parking Loading Zone 10:00 A.M. to 2:00 P.M., Tow Zone -- 11-00140643 - O2011-559;
1	W. Diversey Avenue (north side) from a point 20 feet east of N. Rockwell Street to a point 25 feet east thereof, No Parking Loading Zone 9:00 A.M. to 4:00 P.M. and 6:00 P.M. to 2:00 A.M., Monday through Friday, 9:00 A.M. to 2:00 A.M., Saturday and Sunday, Tow Zone -- 11-00141158 - O2011-582;
3	S. Dearborn Street (east side) from a point 30 feet south of E. 35 <sup>th</sup> Street to a point 25 feet south thereof, At All Times, All Days - O2011-4401;
28	W. Madison Street (north side) from a point 325 feet west of N. Kostner Avenue to a point 25 feet west thereof, No Parking Loading Zone At All Times -- 11-00380414 - O2011-898;
31	4123 W. George to N. Kearsarge Avenue (south side) Loading Zone/Tow Zone (Public Benefit);
32	W. Wabansia (south side) from a point 25 feet east of N. Elston Avenue to a point 60 feet east thereof and also from a point 135 feet east of N. Elston Avenue to a point 25 feet east thereof, No Parking Loading Zone 6:00 A.M. to 3:30 P.M., Monday through Friday, Tow Zone -- 11-00413768 - O2011-1654;
39	N. Elston Avenue (west side) from a point 20 feet south of N. Kilpatrick to a point 70 feet south thereof, 15 Minute Loading Zone use flashing lights 9:00 A.M. to 5:00 P.M., Monday through Friday, Tow Zone -- 11-00808117 - O2011-1932;
