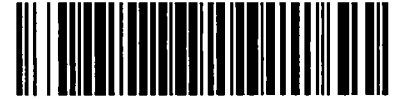

feet west of and parallel to North Rockwell Street,

to those of a C1-1 Neighborhood Commercial District.
