BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

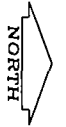
SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B1-3 Neighborhood Shopping District symbols and indications as shown on Map No. 19-H in the area bounded by

North Rogers Avenue; a perpendicular line to West Chase Avenue 165 feet east of the southeast line of North Rogers Avenue (as measured along the north line of West Chase Avenue); West Chase Avenue,

to those of a B3-1 Community Shopping District

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

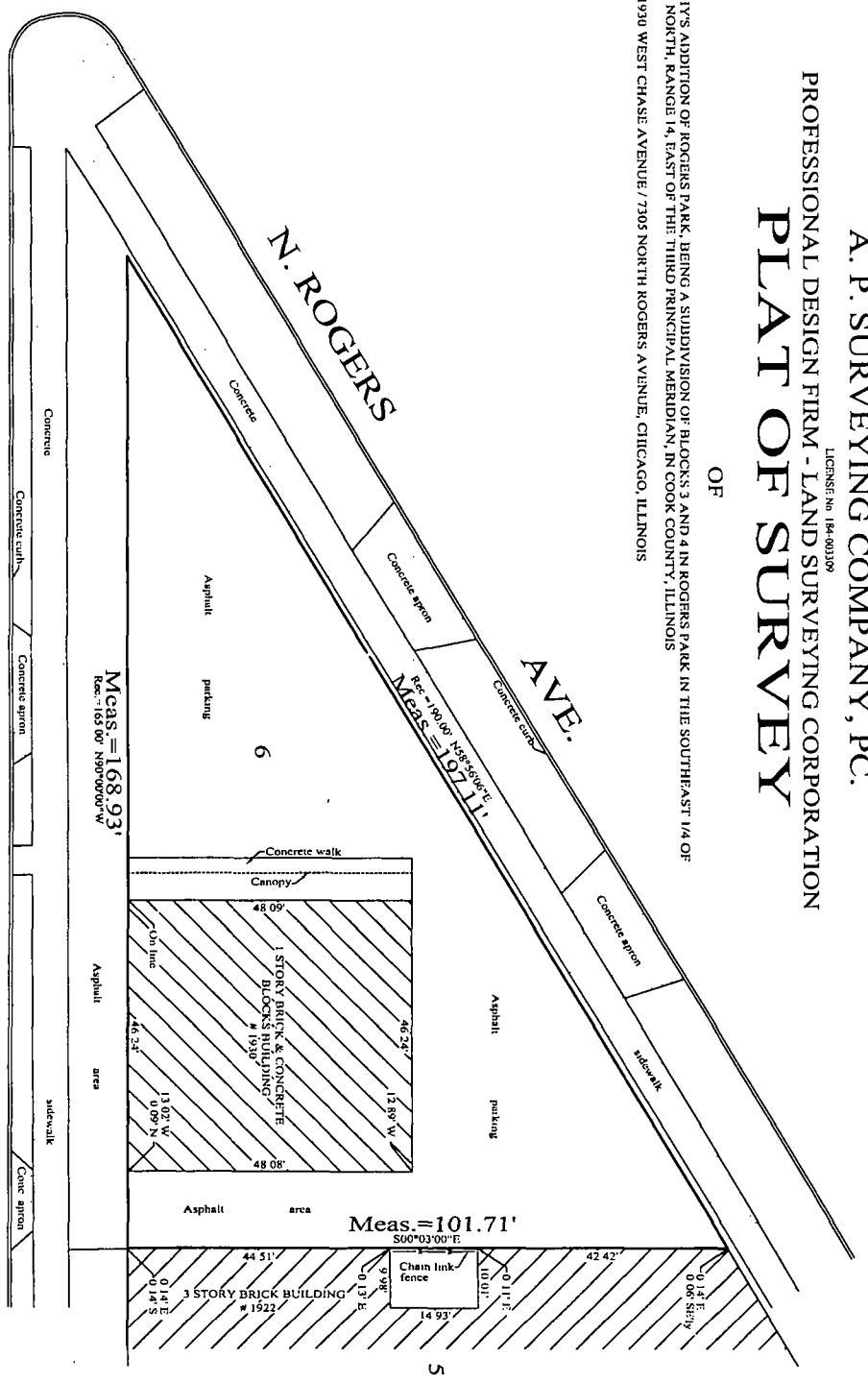
