SECTION 1 That the City Zoning Ordinance be amended by changing all the RS-3 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No. 3-I in area bound by

WEST POTOMAC AVENUE; NORTH CAMPBELL AVENUE; A LINE 50 FEET SOUTH OF AND PARALLEL TO WEST POTOMAC AVENUE; AND, THE PUBLIC ALLEY NEXT WEST OF NORTH CAMPBELL AVENUE.

To those of an RT-4 Residential Two-Flat, Townhouse and Multi-Unit District, and a corresponding use district is hereby established in the area above described.

SECTION 2 The ordinance shall be in force and effect from and after its passage and due publication.

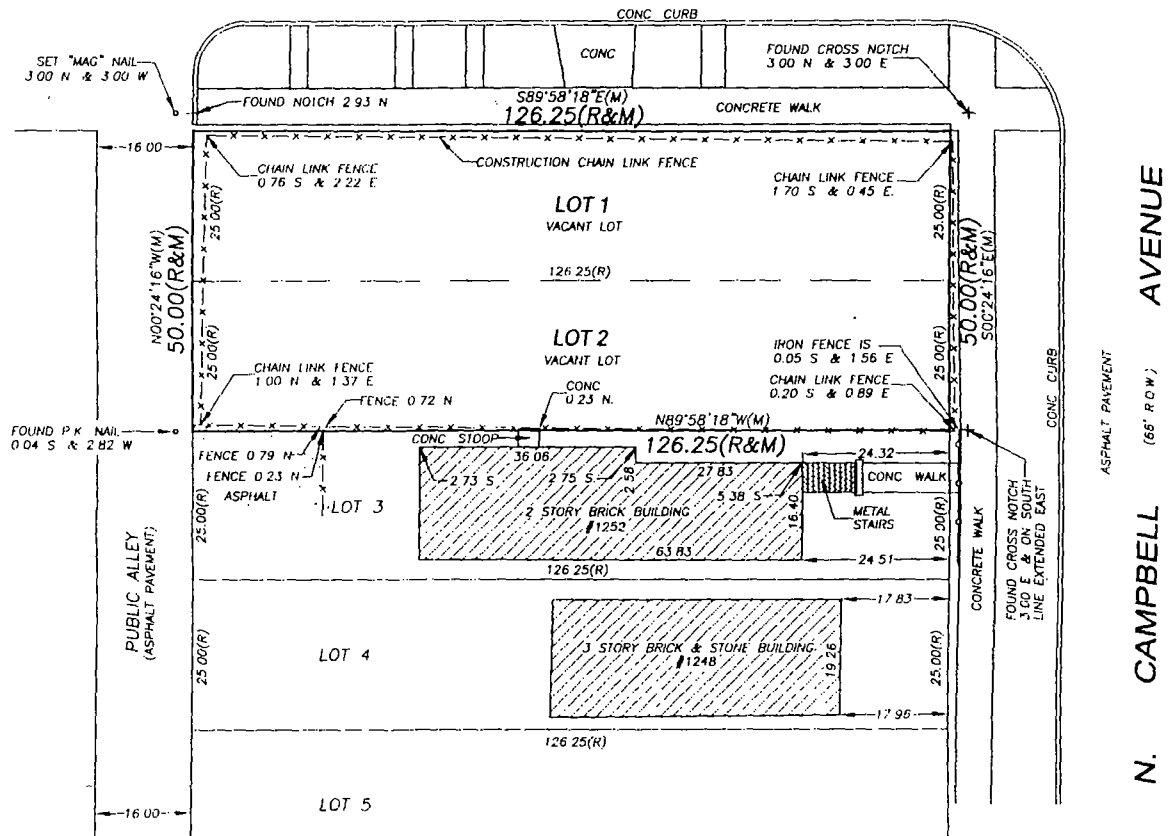
