## MEMORIAL RESOLUTION HONORING THE LIFE OF JIMMIE LEE SAWYER

WHEREAS, Almighty God, in his infinite wisdom and judgment has called to his eternal rest Mr. Jimmie Lee Sawyer, beloved citizen and friend, on Monday, March 23, 2011; and

WHEREAS, This august body has been informed of his passing by the Honorable Emma Mitts, Alderman of the 37<sup>th</sup> Ward; and

WHEREAS, Jimmie Lee Sawyer was born in Mariana, Arkansas on November 6, 1944, to Minnie and John Wesley Sawyer, both who preceded him in death. Furthermore, he was a loving and devoted son; and

WHEREAS, Jimmie Lee Sawyer accepted Christ as his personal savior at an early age, and known as "Big Jim", who was deeply respected and loved by all who knew him; and

WHEREAS, Jimmie Lee Sawyer was a proud, dedicated and long-time resident of the Austin community on Chicago's west side; and

WHEREAS, Jimmie Lee Sawyer attended Farragut High School and showing his deep love and devotion for his country, Mr. Sawyer enlisted in the U.S. Navy, where he attained the rank of Gunner's Mate.
