ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B1-3 Neighborhood Shopping District symbols and indications as shown on Map No. 16-C in the area bounded by

A line 126.93 feet west of and parallel to South Crandon Avenue; the public alley next north of and parallel to East 71st Street; a line 101.93 feet west of and parallel to South Crandon Avenue; and East 71st Street.

To those of a B3-3 Community Shopping District

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

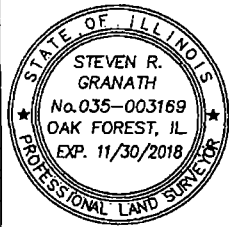
