

I am writing to notify you that on behalf of my client, James Kensik, I will file on or about October 29, 2010, an application for a change of zoning designation from a RM 5 Residential Muhi-Unit District to a B 3-2 Community Shopping District under the Ordinance of the City of Chicago for the property located at 3349 North Sheffield Avenue, Chicago, Illinois, and further described as follows:
