ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the RS3 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No.3-G in the area bounded by

West Fry Street; a line 179.50 feet east of and parallel to North Ashland Avenue; the alley next south of and parallel to West Fry Street; and a line 154.44 feet east of and parallel to North Ashland Avenue,

to those of a RM4.5 Residential Multi-Unit District and a corresponding uses district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.



The existing building will be razed. The proposed new building would also offer a roof top deck and private balconies off of the front of the dwelling units located on the (elevated) 1st floor and the 2nd floor. The proposed building will be all masonry and steel construction and measure 44'-10" in height.

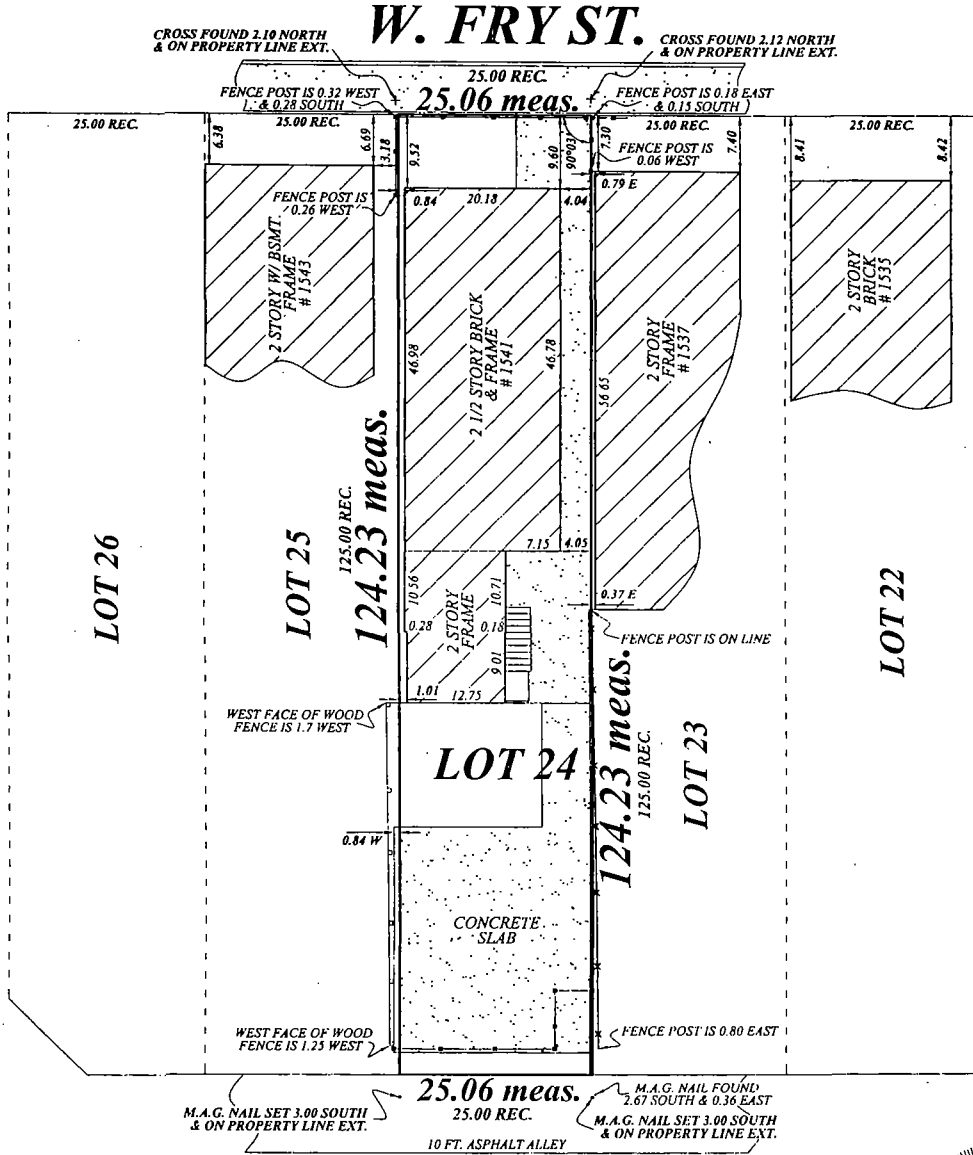
