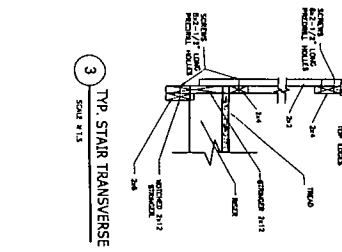

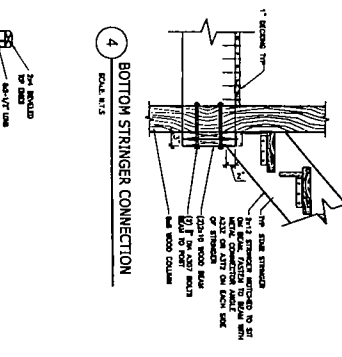
1 (F-1) FOOTING & PIER DETAIL

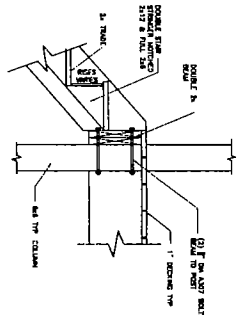
2 TYP. LEDGER CONNECT W/ WALL

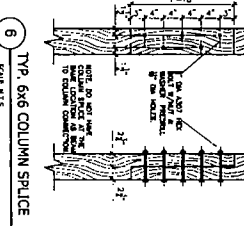
3 TYP. STAIR TRANSVERSE

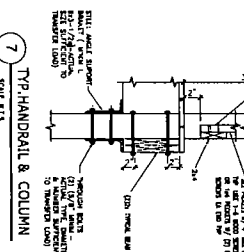

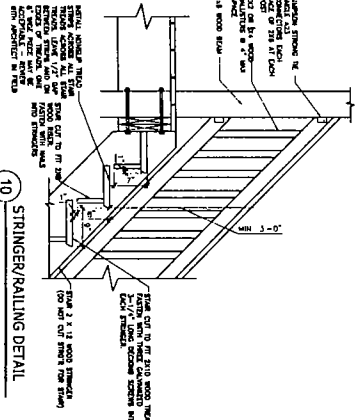

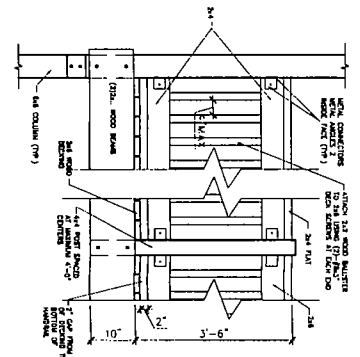

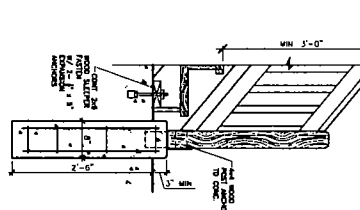

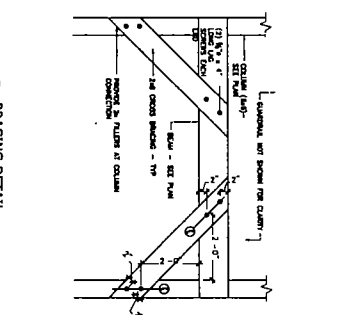
