A line from a point 175.76 feet north of and parallel to West 111th Street;

Chicago Rock Island & Pacific Railroad (Right-of-way) running south westerly 77.71 feet;

A line 100 feet south of and parallel to West 111th Street;

And South Ashland Avenue.

to those of a C1-1 Neighborhood Commercial District.
