340 ON THE PARK CONDOMINIUM ASSOCIATION

*Be It Ordained by the City Council of the City of Chicago:*

SECTION 1. Permission and authority are hereby given and granted to 340 ON THE PARK CONDOMINIUM ASSOCIATION, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, four (4) Retaining Wall(s) with guardrails (handrails) attached on the public right-of-way adjacent to its premises known as 340 E. Randolph Street (Lower Level). Existing retaining walls measure as follows:

- 1) Approximately six (6) feet in length and eight (8) inches in width.
- 2) Approximately seven (7) feet in length and eight (8) inches in width.
- 3) Approximately eight (8) feet in length and eight (8) inches in width.
- 4) Approximately eight (8) feet in length and eight (8) inches in width.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development and Department of Transportation (Office of Underground Coordination).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1116421 herein granted the sum of one thousand six hundred (\$1,600.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

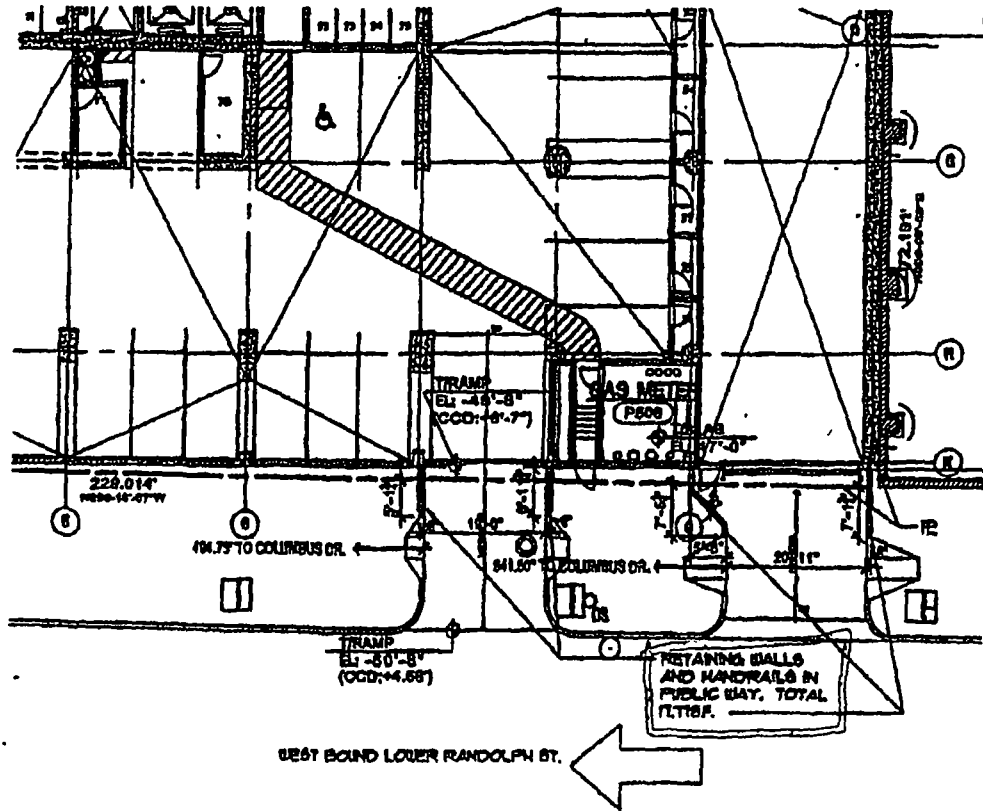

Authority herein given and granted for a period of five (5) years from and after 12/01/2014.
