WEST BALMORAL AVENUE; A LINE 193.98 FEET WEST OF AND PARALLEL TO NORTH DAMEN AVENUE; THE PUBLIC ALLEY NEXT SOUTH OF WEST BALMORAL AVENUE; AND, A LINE 226.98 FEET WEST OF AND PARALLEL TO NORTH DAMEN AVENUE

To those of a RT 3.5 Residential Two-Flat, Townhouse and Multi-Unit District, and a corresponding use district is hereby established in the area above described.

SECTION 2 The ordinance shall be in force and effect from and after its passage and due publication.
