ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the B2-2 Neighborhood Mixed-Use District symbols and indications as shown on Map No.1-H in the area bounded by

the alley next north of and parallel to West Grand Avenue; a line 143.2 feet east of and parallel to North Hoyne Street; West Grand Avenue; and a line 120 feet east of and parallel to North Hoyne Street,

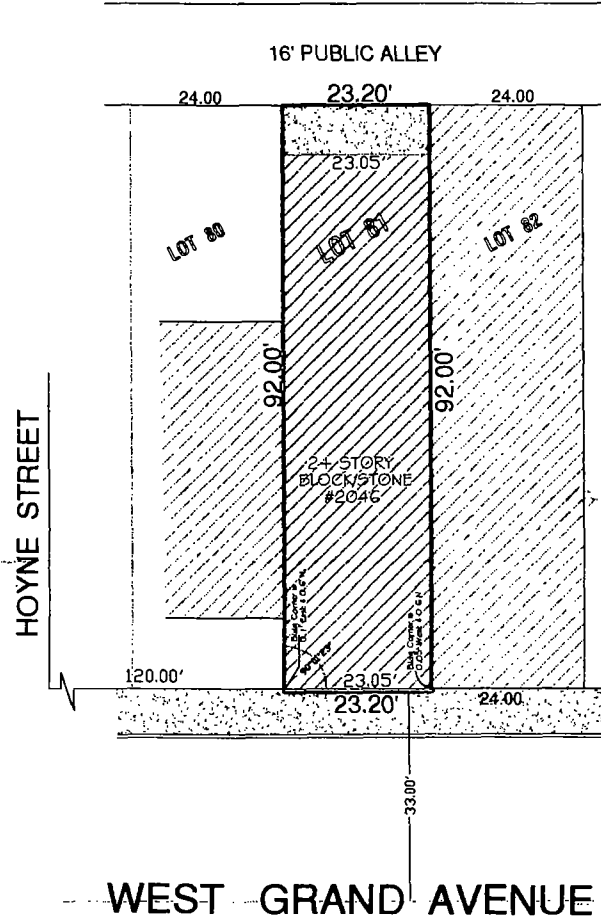
to those of a B3-2 Community Shopping District.



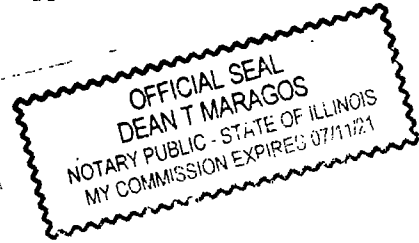


