HSC PLAZA AND BUILDING OPERATIONS LLC

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to HSC PLAZA AND BUILDING OPERATIONS LLC, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use twelve (12) Pipe(s) under the public right-of-way adjacent to its premises known as 3636-3658 N. Clark St..

Said Pipe(s) at N. CLARK ST measure(s):

One (1) at two hundred twenty point seven five (220.75) feet in length, and two point eight (2.8) feet in width for a total of six hundred eighteen point one (618.1) square feet. Said pipe shall be approximately twenty-eight (28) feet in depth.

Five (5) at one thousand ninety-four point five (1094.5) feet in length, and two point eight (2.8) feet in width for a total of fifteen thousand three hundred twenty-three (15323) square feet. Said pipes are approximately twenty-eight (28) feet in depth.

Six (6) at one thousand three hundred twenty-one point four (1321.4) feet in length, and two point eight (2.8) feet in width for a total of twenty-two thousand one hundred ninety-nine point five two (22199.52) square feet. Said pipes shall be approximately twenty-eight (28) feet in depth.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Office of Underground Coordination) and Department of Water Management.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1125107 herein granted the sum of four thousand eight hundred (\$4,800.00) per annum in advance.


A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.


